Police Chief Carpenter stated that two officers are being recognized for the year 2020. The award is given to the officer who has made the most significant contribution to the Police Department throughout the year and who, through their dedication, loyalty, and consistently high quality of work, sets themselves apart as an officer to be emulated. One award is being given to a Squad Officer and the other award to a Mobile Field Force Officer. A plaque was presented to both Joseph Rybialek and Kevin Lawson in recognition for outstanding performance. Carpenter stated that both represented the department with complete professionalism even when confronting abusive people. He advised that the selection for Police Officer of the year is made by the Deputy Chief, both Sergeants as well as himself.

Discussion:

Taylor Prystawsky, owner of River Street Collective, addressed the Board with her request for a liquor license to serve wine and beer in conjunction with a boutique shopping experience. She advised that the outdoor patio on the east side of the building will be utilized for the consumption of alcohol. Trustee Lynam voiced concerns about the patio and questioned if customers would be able to access it without entering the store. Prystawsky said the patio would be enclosed and accessible only from inside the store and will be monitored by staff and outside cameras.

Motion to amend the original motion to include that the approval of the Ordinance Amending the Number of Class 1 Liquor Licenses be contingent upon the completion of securing the back patio so that it is only accessible from inside the store by Mahony/Lynam.

A. FY2022 Budget Workshop

Administrator Johnsen reported that the projections for FY 2022 are significantly better than the budget that was approved. The budget included an overall deficit of \$1,482,134. However, projections indicate that the Village will actually see an overall surplus of \$2,314,490. She explained that one of the reasons for this was that sales taxes were kept stable during the COVID-19 pandemic due to significant outdoor dining options in the Village, the various carry out options, the reopening of indoor dining, the lack of enforcement by the Kane County Health Department, and the continued purchase of vehicles at the car dealerships. She advised that utility taxes also came in above budget due to increased usage. Additionally, building permit and impact fee revenue was significantly more than budgeted because large commercial projects moved forward despite the pandemic. Johnsen added that strict spending controls kept expenditures low.

Motion to recess the Special Committee of the Whole Meeting at 5:59 pm to go into the Regular Village Board Meeting and Public Hearing by Andresen/Mahony.

The Board reconvened the Special Committee of the Whole Meeting at 6:18 p.m.

Each Department Head presented their department's proposed initiatives and projects. In regard to the Village Hall renovation budget, President Miller stated that he would like to see as many renovations done as possible this year. He said that if this requires an increase in the budget, he would like to know what that number would be. Administrator Johnsen agreed that the building needs a lot of work. She stated that there is more money available in reserves for the repairs. Trustee Kunze stated that he would like the budget to include the purchase of a Ford F-150 pick-pp truck for the Public Works Director. This vehicle purchase is currently listed on the deferred list.

There was consensus of the Board for amendments to increase the Village Hall renovation budget and for the purchase of the Public Works Director's pick-up truck. There was also consensus for approval of the proposed FY 2022 Budget and funded initiatives and projects, the proposed Cash Balance Policy and assignment of cash reserves, staffing levels and increases, the water and sewer rates and the refuse fees. Administrator Johnsen advised that the Budget Public Hearing is scheduled for April 19.

Pastor Parchert has requested permission to use State Route 72 for the parade route which will require temporary closure of the road with permission from IDOT. The proposed parade route will remain the same as previous years, beginning in East Dundee on Van Buren Street at Route 72, traveling west on Route 72 and ending at Grafelman Park at 4th Street in West Dundee. Upon Village Board approval, the Resolution requesting for a permit to close Route 72 will be submitted to IDOT for final permission.

RESOLUTION NUMBER ____ - 21

A RESOLUTION APPROVING A REQUEST FOR PERMIT TO CLOSE STATE OF ILLINOIS HIGHWAY, STATE ROUTE 72, FROM THE ILLINOIS DEPARTMENT OF TRANSPORTATION IN CONNECTION WITH THE ANNUAL MEMORIAL DAY PARADE 2021

WHEREAS, the Village of East Dundee is sponsoring a Memorial Day Parade in the Village of East Dundee, and;

WHEREAS, this Memorial Day Parade will require the temporary closure of State Route 72, a State Highway in the Village of East Dundee, and;

WHEREAS, Section 4-408 of the Illinois Highway Code authorizes the Department of Transportation to issue permits to local authorities to temporarily close portions of State Highways for such public purposes.

NOW THEREFORE BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:

Section One. That permission to close State Route 72 for the period from 1:45 p.m. to 2:45 p.m. on Sunday, May 30, 2021, be requested of the Department of Transportation.

<u>Section Two</u>. That if such permission is granted by the Department of Transportation, all highway traffic during periods of time specified shall be detoured over the following routes: Route 72 to Van Buren Street to Barrington Avenue to Water Street to Main Street, in Carpentersville, and thence to Illinois Route 31 to Route 72.

Section Three. That if such permission is granted by the Department of Transportation, the Village of East Dundee assumes full responsibility for the direction, protection and regulation of the traffic during the time the detour is in effect and all liabilities of any kind occasioned by the closing of the State Highway, and it is further agreed that efficient all weather detours will be maintained to the satisfaction of the Department and conspicuously marked for the benefit of traffic diverted from the State Highway. (Detour markings will conform to the requirements of the Manual of Uniform Traffic Control Devices.)

Section Four. That a copy of this Resolution be forwarded to the Department of Transportation to serve as a formal request for the permission sought in this Resolution.

<u>Section Five.</u> Severability. If any section, paragraph or provision of this resolution shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this resolution.

<u>Section Six</u>. Repeal. All resolutions or parts thereof in conflict herewith be and the same are hereby repealed and this resolution shall be in full force and effect forthwith upon its adoption, approval and publication as provided by law.

<u>Section Seven</u>. **Publication.** That a full, true and complete copy of this resolution shall be published within ten (10) days after passage in pamphlet form by authority of the Board.

Subject: Request to Transfer 2021 Home Rule Volume Cap

Date: April 5, 2021

The Federal Tax Reform Act of 1986 imposes a limit on the aggregate amount of "tax exempt private activity" bonds (also known as "Volume Cap") that can be issued by a state. As a Home-Rule community, the Village receives an annual allocation of Volume Cap from the State of Illinois which is distributed based on population. In 2021, Home Rule communities receive a direct allocation equal to their population times \$110 and must obligate their allocation by May 1st of each calendar year, or it transfers back to the State for reallocation outside the region. With East Dundee being identified with a population of 3,192 and receiving an allocation of \$110 per capita, this would amount to a 2021 volume cap allocation of \$351,120.

Private Activity Bonds (PAB) are tax-exempt bonds issued on behalf of businesses engaged in the manufacturing or production of tangible personal property. PAB's can be used to finance the acquisition of fixed assets such as land, buildings, or equipment. They may also be used for renovation and new construction, as well as construction or renovation of residential units that meet income guidelines. The benefit of tax-exempt status is that it effectively lowers the cost of borrowing money for the borrower. The issuance of Private Activity Bonds has no effect on a local government's finances or bonding ability and there is absolutely no financial obligation incurred by a government in the issuance of Private Activity Bonds. In essence the federal tax-exempt nature of these bonds only influences the federal treasury.

Each year, the Upper Illinois River Valley Development Authority (UIRVDA) requests that the Village consider transferring its Home Rule Volume Cap to UIRVDA for economic development and affordable housing projects in the Northeastern Illinois region. The UIRVDA serves the following Illinois counties: Bureau, Grundy, Kane, Kendall, LaSalle, Marshall, McHenry, and Putnam. Transfer of the volume cap to the UIRVDA assists with financing bond projects that otherwise might not move forward. In the past, the agency has been able to pool Volume Cap from the following communities: Arlington Heights, Berwyn, Bloomingdale, Bridgeview, Burbank, Carol Stream, Carpentersville, Countryside, Crystal Lake, Elmhurst, Hoffman Estates, Lincolnwood, Mount Prospect, Oak Park, Oswego, Rolling Meadows, Rosemont, South Barrington, and Wheeling.

Currently, there are three very active Board members from Kane County on the UIRVDA Board of Directors. Because of some relaxed incentives contained in recent federal COVID relief legislation, affordable housing projects financed with tax exempt bonds that require volume cap are expected to increase

in 2021, which will make volume cap availability even more important. The UIRVDA requests that if the Village has no current plan to utilize its volume during 2021, the Village would allow the UIRVDA to use it to benefit the residents of UIRVDA by approving the transfer of its 2021 Home Rule Volume Cap. The UIRVDA can carry forward transferred volume cap for up to three calendar years that further preserves its availability to fund projects.

The Upper Illinois River Valley Development Authority (UIRVDA) respectfully requests your consideration to transfer your unneeded 2021 Home Rule Volume Cap to UIRVDA to support regional economic development and affordable housing projects. UIRVDA has successfully fostered mutual relationships with home rule communities and counties to share this valuable resource for the benefit of the entire region.

In 2021, Home Rule communities receive a direct allocation equal to their population times \$110. The 2021 State of Illinois Allocation guidelines identify East Dundee's population at 3,192 or a total Volume Cap Allocation of \$351,120.

Home Rule communities must obligate their allocation by May 1st of each calendar year, or it transfers back to the State for reallocation outside the region. If the Village would consider passing an ordinance transferring its 2021 allocation to UIRVDA prior to May 1st, then UIRVDA would be able to safekeep the volume cap until December 31st on your behalf and that of the region. We also can carry it forward for three additional years if not used.

ORDINANCE A SPECIAL ORDINANCE AUTHORIZING THE CEDING OF PRIVATE ACTIVITY BONDING AUTHORITY

WHEREAS, the Internal Revenue Code of 1986 provides that the amount of private activity bonds which may be issued by the Village of East Dundee ("City") as a constitutional home rule unit is equal to its population multiplied by \$110.00; and

WHEREAS, the Illinois Private Activity Bond Allocation Act (30 ILCS 345/1 et seq.) provides, among other things, that the corporate authorities of any home rule unit may reallocate to a state agency any portion of its unused allocation of volume cap; and

WHEREAS, the Village of East Dundee has available year 2021 volume cap and desires to utilize this cap in cooperation with the Upper Illinois River Valley Development Authority (UIRVDA) to support the projects that will create jobs and expand the Village's tax base;

NOW THEREFORE, be it ordained by the Village Council of the Village of East Dundee, Illinois:

Section 1. <u>Consent to Reallocate to UIRVDA</u>. The Village hereby agrees to reallocate to the Upper Illinois River Valley Development Authority its 2021 private activity volume bonding cap in the amount of \$351,120. Said private activity volume bonding cap shall be used to support projects that will provide job opportunities and new investments.

Section 2. <u>Letter of Agreement</u>. The Village Finance Director is hereby authorized to execute a letter of agreement with UIRVDA consenting to such allocation on behalf of the Village as authorized.

Section 3. <u>Maintaining Records</u>. The Village Finance Director is hereby authorized to maintain such record of the allocation for the term of the bonds issued pursuant to such allocation.

Section 4. Notice. The Mayor shall provide notice of such allocation to the Office of the Governor.

Section 5. Effective Date. This ordinance shall be effective from and after its passage.
