

ORDINANCE NUMBER 19 - 08

AN ORDINANCE OF THE VILLAGE OF EAST DUNDEE,  
COOK AND KANE COUNTIES, ILLINOIS, CHANGING  
THE NAME OF PLATE DRIVE EAST OF THE EAST  
RIGHT-OF-WAY LINE OF CHRISTINA DRIVE, FOR A  
DISTANCE OF THREE HUNDRED NINETEEN FEET, TO RENA ROAD

**WHEREAS**, the Village of East Dundee ("Village") is a home rule unit of local government pursuant to Section 6 of Article VII of the Constitution of the State of Illinois, and has the authority to exercise any power and perform any function pertaining to its government and affairs; and

**WHEREAS**, pursuant to Section 11-80-19 of the Illinois Municipal Code, 65 ILCS 5/11-80-19, and Section 91.101 of the Village of East Dundee Village Code, the President and Board of Trustees of the Village have the authority to change the name of any street within its boundaries;

**WHEREAS**, the President and Board of Trustees of the Village have deemed it to be in the best interest of the Village that the name of Plate Drive east of the east right-of-way line of Christina Drive, for a distance of three hundred nineteen feet (319') as depicted in EXHIBIT A attached hereto and made a part hereof, be changed to Rena Road;

**NOW THEREFORE BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:**

**SECTION 1: Incorporation.** That each Whereas paragraph above is incorporated by reference into this Section 1 and made a part hereof as material and operative provisions of this Ordinance.

**SECTION 2: Name Change.** That pursuant to the Village's home rule powers, Section 11-80-19 of the Illinois Municipal Code, 65 ILCS 5/11-80-19, and Section 91.101 of the Village of East Dundee Village Code, the name of Plate Drive east of the east right-of-way line of Christina Drive, for a distance of three hundred nineteen feet (319') as depicted in EXHIBIT A attached hereto and made a part hereof, is hereby changed to Rena Road.

**SECTION 3: Notice of Name Change.** That pursuant to Section 11-80-19 of the Illinois Municipal Code, 65 ILCS 5/11-80-19, the change in name in Section 2 above shall not be effective until thirty (30) days after the election authorities having jurisdiction in the area in which the name of Plate Drive is changed and the post office branch serving said area have been notified by the Village's Corporate Authorities in writing by certified or registered mail.

**SECTION 4: Village Clerk To Notify.** That the Village Clerk is authorized and directed to provide the notice referred to above in Section 3 by forwarding a certified copy of this Ordinance to said election authorities and post office branch.

**SECTION 5: Severability.** That if any Section, paragraph or provision of this Ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such Section, paragraph or provision shall not affect any of the remaining provisions of this Ordinance.

**SECTION 6: Repeal.** That all ordinances, resolutions, motions or parts thereof in conflict with this Ordinance shall be and the same are hereby repealed.

**SECTION 7: Effect.** That this Ordinance shall be in full force and effect upon its adoption, approval and publication in pamphlet form as provided by law.


