

Ordinance No. 19 - 24

**AN ORDINANCE OF THE VILLAGE OF EAST DUNDEE, ILLINOIS  
CREATING A SPECIFIC AND LIMITED RIDE SHARE PARKING ZONE  
(10 N. River Street)**

**WHEREAS**, the Village of East Dundee (the “*Village*”) is a duly organized and validly existing home-rule municipality created in accordance with the Constitution of the State of Illinois of 1970 and the laws of the State; and,

**WHEREAS**, Section 11-208(a)6 of the Illinois Vehicle Code (625 ILCS 5/11-208(a)6) authorizes a municipality to designate no parking zones within its jurisdiction; and,

**WHEREAS**, the President and Board of Trustees have received a recommendation from the Village staff to create a no parking zone for the purpose of facilitating ride share services.

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of East Dundee, Cook and Kane Counties, Illinois, as follows:

**Section 1: Incorporation.** That each Whereas paragraph above is incorporated by reference into this Section 1 and made a part hereof as material and operative provisions of this Ordinance.

**Section 2: Village Code Amendment.** That Section 72.01, Parking Regulations, of the Code of the Village of East Dundee, is hereby amended by adding the following no parking restrictions:

Street	Location	Side of Street	Special Provisions
River Street	Between Main Street and Jackson Street	East	Thursday through Sunday Only from 11:00 p.m. to 3:00 a.m. Excludes rideshare services (e.g. taxis, Uber, Lyft, etc.)

**Section 3: Continuation.** That all provisions of the Village Code not amended herein shall remain in full force and effect.

**Section 4: Severability.** That if any Section, paragraph or provision of this Ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such Section, paragraph or provision shall not affect any of the remaining provisions of this Ordinance.

**Section 5: Repeal.** That all ordinances, resolutions, motions or parts thereof in conflict with this Ordinance shall be and the same are hereby repealed.

**Section 6: Effect.** That this Ordinance shall be in full force and effect upon its adoption, approval and publication in pamphlet form as provided by law.


