# **HEMPFIELD AREA FIRE SERVICES COMMISSION**

Nearly one year ago East Hempfield Township Board of Supervisors and East Petersburg Borough Council came together to create the Hempfield Area Fire Services Commission. On Wednesday, March 3, 2021 the newly hired Chief Fire Official, John A. Kottmyer, was publicly introduced at the East Hempfield Township Board of Supervisors meeting.

The Hempfield Area Fire Services Commission is made up of members of the East Hempfield Township Board of Supervisors, the East Petersburg Borough Council, the East Peterburg Fire Company, the Hempfield Fire Department, and the Rohrerstown Fire Company, as well as citizen at large representatives from each municipality.

The Chief Fire Official position was created to administer a regional fire services program for the municipalities to ensure the protection and preservation of health, safety, and wellness for municipal citizens and businesses through increased uniformity and continuity of fire protection while minimizing operating costs and maximizing volunteer recruitment and retention.

Chief Kottmyer retired from York City Fire Department as a Deputy Chief, and has since served as the EMS Manager for Wellspan Health and the Director of Education for VFIS, a division of Glatfelter Insurance Group. Chief Kottmyer brings a variety of experience both on and off the fire scene and is an integral addition to the Fire Commission and the provision of fire services within our communities.

# Looking Back at 2020 & Looking Forward to 2021

Looking back at 2020 it will be remembered as the Year of COVID and uncertainty. But one thing was certain, local government was there for you and did not close its doors at any time during the pandemic. East Hempfield Township staff and our first responders worked tirelessly over the last year meeting critical needs and continuing services that our residents depend on. We are here to serve you. Even with the pandemic, work continued in the Township in 2020. \$1.3M was spent paving our roads, continuing a decade long trend where funding for roadwork was increased (doubled) to catch up on roadway maintenance that was deferred in the 1990's and early 2000's. Our Recreation Authority who oversees the Four Seasons Golf Course operations successfully negotiated a lease arrangement with Blue Collar Restaurant and Catering. The Blue Collar Restaurant is undergoing renovations to the space and hopes to be open in late spring. By making this change, including transferring catering services over to Blue Collar has resulted in the golf course projecting operating revenue to be in the black going forward. Past years the Township was forced to subsidize the golf course operations, sometimes substantially. East Hempfield Township and East Petersburg Borough joined forces to create the Hempfield Area Fire Services Commission. More on this topic can be found in the newsletter. Amos Herr Park Trail was expanded around the park and was heavily used during the pandemic, providing outdoor exercise options. Finally, after years of delay from AMTRAK, roadwork continued on State Road at the Route 283 interchange and will be complete this summer resulting in an efficient, safe interchange.

Looking forward to 2021, the Township will continue to focus on transportation issues, including Stony Battery Road and Good Drive. Projects and plans to fund them are being developed for these two important North-South corridors in the form of grants and township funds. \$1.15 million dollars is budgeted for 2021 road paving projects, to continue the accelerated paving program. Also, Centerville Road (South) from Columbia Avenue to Marietta Avenue will begin construction in the Fall to widen to 5-lanes and reconstruct the Route 30 bridge. This project is primarily funded by PennDOT (100% around the interchange, and 80% north and south of the interchange) and supplemented with Township funds. Centerville Road, with the exception of the Route 30 bridge, is owned by East Hempfield Township so the additional PennDOT funds are greatly appreciated for this \$50 million project. Stormwater projects, primarily around Harrisburg Pike and north of Four Seasons Golf Course, will also be constructed as the Township continues to address flooding issues from development in the 1980's. Finally, East Hempfield will complete and adopt an Official Map, an important planning tool that provides a roadmap for the next 20-years for road projects, parks, trails and stormwater facilities. More information on our official map can be found on the Township website.

Financially, the Township is doing well even with the issues caused by the pandemic that have decreased revenue and increased expenses. For the 11th year in a row, the Township has controlled cost, held the line on property tax increases



and placed another \$900,000 into the Capital Reserve Fund to tackle major infrastructure projects, with a focus on road projects such as the Centerville project. For the next few years budget forecasts show that trend will continue. However, we are facing new financial pressures with continued unfunded mandates from both the State and Federal Governments. A big unfunded mandate is the Chesapeake Bay cleanup where the costs have been pushed down onto the local government and local tax payers. However even with these mandates we are committed to living within our means, maintaining important services and continuing investing in our road infrastructure.

East Hempfield Township continues to be a great place to work, live in and raise a family. Our focus of maintaining the high quality of life that we have here, providing the necessary services that our residents and businesses need, and ensuring that the tax payers get great value for what they are financing is the reason we were able to successfully navigate the COVID19 challenges in 2020 and will be the blue print for success for years to come.

### 2020 ACCOMPLISHMENTS:

- Exercised strong fiscal management practices to provide a higher than projected opening fund balance in 2021.

- Four Seasons Banquet Facility The Recreation Authority, who oversees the golf operations, successfully negotiated a lease arrangement with Blue Collar Restaurant and Catering. The Blue Collar Restaurant is undergoing renovations and they hope to open in late spring.
- Hempfield Area Fire Services Commission The Township of East Hempfield and the Borough of East Petersburg joined together to form the Hempfield Area Fire Services Commission, More on this can be found in this newsletter.
- Amos Herr Park Trail The perimeter trail around the park was completed last year. The Township will continue to make improvements and interior connections to facilities.
- Began the "Official Map" project which will result in a planning map to provide guidance to the Township along with the other planning documents that are used (i.e. Zoning Ordinance, Comprehensive Plan, Stormwater Management Plan...)
- Initiated a vehicle leasing program through Enterprise Fleet Management. This will be used to stabilize vehicle replacement and maintenance costs.
- Successfully negotiated with Penn State Health for Community Support dollars for the Township.
- Developed a COVID-19 Operations and Preparedness plan which aided in the Township maintaining the health of employees and provide continued services to Township residents.
- Updated the Police Department's Use of Force Policy to reflect national and state standards.

### 2021 GOALS:

- Increase the level of transparency in municipal operation and direction. This is anticipated to be accomplished by a stronger social media presence and improved electronics for video and audio for public meetings.
- Continue to support the Recreation Authority in their quest to find additional sources of revenues to supplement and complement Golf Course operations.
- Continue to push long-term roadway projects forward (Old Rohrerstown Road bridge, Centerville South).
- Initiate the self-assessment phase of the Police Department Accreditation Process and hire a consultant.
- Create the administrative sergeant role and promote a new sergeant. Hire the 34th Police Officer. (accomplished 2/17/2021)
- Purchase and implement Body Worn Cameras for the Police Department.
- Continue to address and move forward with annual Board goals.
- Implement the 2018-2023 MS-4 Permit, by continuing to meet the Pollutant Reduction Program requirements, continuing Best Management Practice (BMP's) inspections, and continuing the outfall inspections.
- Begin the preparation for the next MS-4 Permit cycle (2023)
- Address stormwater issues in several areas of the Township, including Harrisburg Pike and the Golf Course Property.
- Continue to work with East Petersburg Borough and the three Fire Departments (Hempfield, Rohrerstown and East Petersburg) to expand the role of the Hempfield Area Fire Services

### ZONING FREQUENTLY ASKED QUESTIONS

**Do fences require a permit?** Fences do not require a permit however they do have regulations for height and location. Fences may be 6 feet high behind the front of the house and 4 feet high in front of the house. Fences may not be located within any drainage easement or street right-of-way.

# What is considered impervious versus pervious?

Pervious area is defined as surface area that allows water to pass through it.

Impervious area is surface area that does not allow water to pass through.

Decks are considered pervious if they cover grass, dirt, landscape stone, and mulch.

Decks are considered impervious if they cover concrete, asphalt, pavement, and pavers.

# Are chickens allowed in residential zones?

No, chickens are livestock, and livestock is not permitted in residential zones.

# **ROAD PROJECT UPDATES**

**Church Street Resurfacing (Harrisburg Pike** – **Stony Battery)** – Bid date on this Penn-DOT project has been to moved January 2022. The project will consist of mill and overlay of the existing roadway with new sidewalks/curbs in the Landisville area, a straightening of the curve and replacement of the stormwater culvert near the golf course. PennDOT anticipates a 7-month project which includes a 2-month road closure while the culvert is replaced.

**Centerville Road Interchange Improvements** (Marietta-Columbia) – The Township is partnering with PennDOT on this multiyear project which continues to move through the planning process. The bid date on this project has been moved to September 2021 with a potential for an extension as right-of-way acquisition and utility coordination occurs. The project will widen Centerville Road to 5 lanes and raise the bridge at the interchange. The project will be a multiyear construction project.

### <u>STATE ROAD WORK:</u> State Road Interchange Improvements –

This PennDOT project is under construction. Completion is anticipated for August 2021. Rt 722 will remain open during the construction but delays should be expected during peak construction periods.

State Road Commerce Park & Improvements to Yellow Goose/State Road intersection – The developers of the State Road Commerce Park complex (Kellogg's warehouse) have made some improvements to the intersection. Remaining work will be done in the Spring/Summer 2021 in conjunction with the interchange project and the State Road Penn State/Brookside Development. The Yellow Goose/State Road intersection will be improved to provide a 4-way intersection with the proper through and turning lanes.

**State Road Penn State Medical Center/ Brookside Development** – The final project along the State Road corridor will be the widening, bridge replacement, and adding of a traffic signal along the frontage of the Penn State/Brookside Development. This project is scheduled for installation of the road base in early spring and opening in late spring/early summer of 2021.

Each of the responsible entities, along with the Township, are coordinating their efforts to complete all of the State Road corridor work as efficiently and timely as possible. The Penn State Hospital is scheduled to open (accepting patients) in Spring 2022.

**Holland Street Bridge Removal Project** – This bridge has been removed under an emergency permit through Penn-DOT.

**Old Rohrerstown Road Bridge Replacement Project** – This Dairy Road project will improve the bridge beneath the Norfolk Southern rail line. Utility coordination continues to be the difficulty in getting this project into the bid process. The bid date for this project has been moved to Fall 2021.

**Farmingdale Road Improvements** – Longterm improvements include a traffic signal at Oreville and Good, lane improvements at Marietta and Good and the addition of a limited right turn on to Oreville Road for southbound Farmingdale traffic. The Township is acquiring necessary right-of-way and awaiting the issuance of the Highway Occupancy Permit from PennDOT. Bidding for this project is scheduled for early Spring 2021 and will be a 4-6 month construction period.

### **Township Burning Ordinance**

**Reminder:** Burning of woody yard waste, grass & leaves, garbage, rubbish, and construction material is PROHIBITED throughout the Township (AG exception).

# **Recycling Right Doesn't Have to Be Hard**

Only the **Big 4** should be placed in your recycling bin:

### WHEN IN DOUBT, THROW IT OUT!



- Glass Jars & Bottles (emptied, rinsed & lids removed)
- Corregated Cardboard (flattened)
- Metal food and Beverage cans (emptied, rinsed & lids removed)
- Plastic bottles & jugs with necks (emptied, rinsed & lids removed)

### **EVERYTHING ELSE IS TRASH.**

If you think something may be recyclable (like newspaper or plastic bags), visit <u>earth911.com</u> (where to recycle, at the top of the page) for a list of potential drop-off locations. Otherwise, place the material in your trash.

Do not put anything other than the **Big 4** in your recycling bin.

### **WHERE DOES YOUR TRASH GO?**

The Lancaster County Solid Waste Management Authority (LCSWMA) has the answer! All County trash and recycling flows through the LCSWMA

Transfer Station on Harrisburg Pike. Please visit their website for a wealth of useful information (<u>www.lcswma.org</u>) and a virtual learning experience (<u>www.lcswma.org/tours-2/</u>) which leads you through the process and answers the question, where does your trash go...



### COMMERCIAL, INDUSTRIAL & INSTITUTIONAL RECYCLING

- Are you a commercial, industrial or institutional entity?
- Do you recycle materials such as office paper, corrugated cardboard, tires or large appliances?
- Do you rely on a licensed waste hauler to transport your recyclables?

If you answer **YES** to all of the above we thank you for doing what is necessary to track your recycling efforts.

If the answer to the last question is **NO**, the Township would like to have additional information from you to better understand how your recycling efforts are accounted for in the waste stream. Please contact us at your earliest convenience.



### RUNS FROM APRIL 5 - OCT. 29, 2021

- An unlimited amount of recyclable paper bags are permitted per week though each may not exceed 30 lbs.
- Unlimited amount of bundled material tied with twine permitted per week, may not exceed 30 lbs. or 4 feet in length.
- Recyclable paper yard bags may be purchased wherever sold.
- Do not mix yard waste with household trash during yard waste season.
- If you have a truck or trailer full of yard waste contact your local compost site.

### **Trees & Shrubbery**

Improper placement of trees & shrubbery can become a danger for motorists exiting an intersection or driveway. Please plan accordingly when planting new foliage. They should be placed so that they will not grow into the street or into overhead wires. Without prior notice, the Township

and other utility companies will trim trees & shrubs that grow into & over the roadway.

If you prefer to have a professional tree trimmer maintain your **trees & shrubbery**, please keep them at approximately 14' high and a minimum of 3' behind the curb or white line.


# **SPRING STORMWATER MANAGEMENT**

### Ways to reduce stormwater runoff while improving wildlife habitat

Native plants are trees, shrubs, flowers, grasses and other plants that provide a less labor intensive and water efficient landscape which is beneficial to home owners and the environment. Native plants are preferred because they grow well in the area's soil and weather conditions. The extensive and deep root systems of native plants help reduce runoff, reduce soil erosion, and filter water before it gets into the nearby waterways.

# **SCAM PREVENTION TIPS**

Here are useful tips to help you avoid becoming a victim of a scam or fraud.

### **GIFT CARD SCAMS:**

If you receive an email, phone call, or text message from someone asking you to buy gift cards or prepaid credit cards for them, it is likely the start of a scam meant to steal your money.

### What to do:

- Never give your personal or financial information in response to a request that you didn't expect.
- Never pay someone who insists you pay with a gift card or by using a money transfer service.
- Never deposit a check and send money back to someone.
- Block unwanted calls and text messages.
- Resist the pressure to act immediately.
- Before you do anything else, tell a friend, a family member, a neighbor.

### **HOME IMPROVEMENT FRAUD:**

### Be cautious of contractors who:

- Do not have a PA contractor license number.
- Claim to "just be in the neighborhood".
- Claim that they can offer you a deal because they have "surplus material" offered at a lower price.
- Claim that they can give you a discount if you "act right away".
- Demand upfront payment, or offer to arrange financing.

#### **Always:**

- Verify the registration of a contractor.
- Insist on seeing references.
- Request a bid in writing, and compare to bids from multiple contractors before agreeing to any work.
- Check the Better Business Bureau website for a review of the contractor.
- Get a written contract before the work starts and before you pay anything.
- Do not pay the final bill until all work has been completed.
