Resolution authorizing a Cash Management Plan

WHEREAS, it is the desire of the governing body to adopt a cash management plan to comply with the requirements of NJSA 40A:5-14 and to provide a guide to municipal officials and employees in carrying out their duties concerning the receipt and disbursement of all funds of the municipality; and

WHEREAS, the following requirement shall be adhered to:

I. Statement of Purpose

The Cash Management Plan is prepared pursuant to the provisions of NJSA 40A:5-14 in order to set forth the basis for the deposit and investment of certain public funds of the Township of Egg Harbor, in the County of Atlantic, State of New Jersey pending the use of such funds for the intended purposes. The Plan is intended to assure that all public funds identified herein are deposited in interest bearing Deposits otherwise invested in Permitted Investments hereinafter referred to. The intent of the Plan is to provide that the decisions made with regard to the Deposits, Transfers and the Permitted Investments will be done to ensure the safety, liquidity, and the maximum investment return within such limits. The Plan is intended to ensure that any Deposit or Permitted Investment matures within the time period that approximates the prospective need for the funds deposited or invested so that there is not a risk to the market value of such Deposits or Permitted Investments.

II. Authorized Depositories

The Municipality shall annually designate the legal depositories, funds in certificates of deposits, and other time deposits in banks by resolution in accordance with NJSA 40A: 5-15.1, that must be covered by the Governmental Unit Depository Protection Act, NJSA 17:9-14 et seq. (GUDPA). The Municipality is also authorized to invest its assets in the New Jersey Cash Management Fund and the New Jersey Asset and Rebate Management program. This resolution may be amended or supplemented from time to time, as the Municipality deems necessary. Such resolution shall be deemed a part of the Cash Management Plan.

III. Authorized Investment

Except as otherwise specifically provided for herein, the Designated Official is hereby authorized to invest the public funds covered by the Plan, to the extent not otherwise held in deposits, in the following permitted investments:

1. Bonds or other obligations of the United States of America or obligations guaranteed by the United States of America.
2. Government money market mutual funds.
3. Any obligation that a federal agency or a federal instrumentality has issued in accordance with an act of Congress, which security has a maturity date not greater than 397 days from the date of purchase, provided that such obligation bears a fixed rate of interest not dependent on any index or other external factor.

4. Bond or other obligations of the Local Unit or bonds or other obligations of school districts of which the Local Unit is a part of within which the school district is located.
5. Bonds or other obligations, having a maturity date not more than 397 days from the date of purchase, approved by the Division of Investment of the Department of the Treasury for investment by Local Units.
6. Local government investment pools.
7. Deposits with the State of New Jersey Cash Management Fund established pursuant to section I of P.L. 1977, c. 281 (C.52:18A-90.4); or Agreement for the repurchase of fully collateralized securities if
 - a) the underlying securities are permitted investments pursuant to paragraphs (1) and (3) of this subsection a;
 - b) the custody of collateral is transferred to a third party;
 - c) the maturity of the agreement is not more than 30 days;
 - d) the underlying securities are purchased through a public depository as defined in section I of P.L. 1970. C.236 (C.17:9-41); and
 - e) a master repurchase agreement providing for the custody and security of collateral is executed.

IV. Authorized Signatures

The Municipality shall annually establish by resolution and adopted at its annual reorganization meeting the required signatories to all bank accounts.

V. Identification of Funds and Accounts to be covered by the Plan

The Plan is intended to cover the deposit and/or investment of the following funds and accounts contained in each fund of the Township of Egg Harbor:

Current Fund
 Performance Guarantee
 Developer's Escrow
 Dog License Fund
 Law Enforcement Trust Funds
 Recreation Trust
 All Other Trust Funds

The following funds shall not be required to be maintained in interest bearing accounts:

Change Funds
 Petty Cash Funds
 Payroll Funds

Trust Funds – to the extent that the deposit of such funds to an interest bearing account would require by law the payment of interest to the provider of funds.

Checking Accounts – established for the express purpose of paying bills approved by the governing body. The balances in these funds shall be kept at the minimum amount required for the orderly operation of the account.

Compensating Balances – maintained for the purpose of obtaining specific services from financial institutions. Such accounts shall be established only under terms of written agreements approved by the governing body.

VI. Designation of Officials of the Township of Egg Harbor Authorized to Make Deposits, Transfers and Investments Under the Plan.

The Chief Financial Officer of the Township of Egg Harbor and the CFO's designee are hereby authorized and directed to deposit, transfer and/or invest the funds referred to in the Plan. The CFO or CFO designee shall each have the authority to transfer and invest funds in excess of requirement in accordance with this plan in insured obligations, overnight repurchase agreements, collateralized repurchase agreements and certificates of deposit with eligible public depositories qualified by this plan.

In the absence of the Chief Finance Officer, the CFO's designee is authorized to transfer required funds to the payroll and checking accounts for the purposes of, and to the extent necessary for, issuance of required payroll and payment of claims and payables.

Prior to making any such Deposits, Transfers, or any Permitted Investments, such officials of the Township of Egg Harbor are directed to supply to all active depositories or any other parties with whom the Deposits or Permitted Investments are made a written copy of this Plan.

No municipal funds shall be disbursed by any municipal official prior to approval of the governing body except for:

Debt Service payments
Investments and/or Transfers to/from Township of Egg Harbor Current,
Capital, Trust Funds.
Payroll turnovers to agencies
Discount vouchers or immediate needs

Debt Service payments, discount vouchers and immediate needs must be ratified after payment.

VII. Responsibilities

The Chief Finance Officer or Designee of the Chief Finance Officer:

1. Shall ensure that all funds held by the Township are safeguarded in accordance with these procedures and applicable law.
2. Shall maximize the Township's interest income by prudently investing funds in excess of immediate needs in assets providing a high level of security for both principal and interest earnings, and in accordance with the rules and regulations of the State of New Jersey and the Township's Bond Documents.
3. Shall maintain records and control of all Township bank accounts, petty cash and change funds, investments, and certificate of deposits.
4. Shall ensure adequate separation of duties between authority to transfer or invest funds and the responsibility for recording in, accounting for and reconciling the Township's ledgers and other books of account.
5. Shall provide a monthly report that provides the summary of financial balances for revenues and appropriations.
6. Shall provide a report that summarizes investment made or redeemed in the past month, each organization holding local unit funds, and the amount of securities purchased or sold, class or type of securities purchased, book value, earned income, fees incurred, and market value of all investments as of the report date, and any other information that the governing body may request or the CFO deems prudent to report.

VIII. Liability

Provided that local unit funds are deposited or invested as designated or authorized by this cash management plan, the Chief Financial Officer and the CFO designee is relieved of any liability for any loss of such moneys due to the insolvency or closing of any depository

LICENSE & OPERATIONS AGREEMENT – L.23.07d

THIS LICENSE & OPERATIONS AGREEMENT is made this ____ day of _____, 2023 between ATLANTIC COUNTY, a body corporate and politic of the State of New Jersey, with offices located at 1333 Atlantic Avenue, Atlantic City, New Jersey (hereinafter referred to as the “Licensee”), and EGG HARBOR TOWNSHIP, a municipal corporation of the State of New Jersey (hereinafter referred to as “Licensor.”).

WHEREAS, the Atlantic County Division of Intergenerational Services desires to operate nutrition sites in various municipalities throughout the County, and

WHEREAS, the Egg Harbor Township has the ability to provide the necessary facilities for the operation of the nutrition site, and

WHEREAS, the Local Lands and Buildings Law, N.J.S.A. 40A:12-1 et seq. permits the County and municipalities.

TERMS & CONDITIONS

1. **Grant of License:** The Licensor hereby grants unto Licensee and Licensee accepts for itself, its members, officers, agents and invitees this License and permission to conduct the following operations within the License Area: Atlantic County Nutrition Project under a federally funded program. Licensee may also provide programs specified under the Older American Act.

Use of the property shall be subject to the terms set forth herein. No activities shall be conducted within or upon the property by the Licensee, its agents, employees, representatives, or anyone acting on the Licensee's behalf, other than the activities specifically permitted herein, unless Licensee first obtains written permission from the Licensor.

2. **Description of the Licensed Premises:** The License Area is the property owned by the Licensor, commonly known as Egg Harbor Township Community Center, 5045 English Creek Avenue, Egg Harbor Township, New Jersey. The Licensed Premises shall consist of the multipurpose room (Room 138), kitchen (Room 133), restroom facilities (Rooms 135 & 136), one office (Room 134), and one storage room (Room 132).

3. **Term of the License:** The initial term of this License shall be for a three (3) year period, commencing January 1, 2024 and terminating December 31, 2026. The Licensee's authority to use and operate and gain access to the License Area shall be subject to the following time limitations: Licensee shall have the right to use and operate and gain access to the Licensed Premises, Monday through Friday beginning at 9:00am and concluding at 2:00pm. Should the Licensee desire to use and occupy the Licensed Premises outside of the established times, the Licensor shall provide such permission in writing, which shall not be unreasonably withheld.

4. **Licensee Fees and Costs:**

A. **Payment.** The Licensee and Licensor hereby agree that the provision of the services by Licensee to the public constitute good and adequate consideration in exchange for this license and right to use and access the License Premises. The yearly rate for janitorial services and trash removal is specified in Sections D and E below. The Licensee shall pay to Licensor a total amount, for the three-year contract term, not to exceed \$55,755.41 for janitorial services and trash removal.

B. **Utilities.** Licensor is to provide gas, electric, and water to the Licensed Premises. Licensee is not responsible for the cost of any utilities.

C. **Telephone.** Licensee shall be liable for the sole cost of a telephone which sole purpose is the exclusive use of Licensor. Licensee should ensure that the telephone and telephone line provided for Licensor's exclusive use shall not be used by any other party outside the time Licensee has access to the Licensed Premises.

D. **Janitorial.** Licensee agrees to pay to Licensor the following amount per year for janitorial services of the Licensed Premises: \$14,868.00 for the term commencing January 1, 2024 and terminating December 31, 2024; \$15,611.40 for the term commencing January 1, 2025 and terminating December 31, 2025; and \$16,391.97 for the term commencing January 1, 2026 and terminating December 31, 2026. In the event the State of New Jersey amends the state minimum wage laws, this section shall be revised to reflect the new minimum wage in the salary calculation.

E. **Trash Removal.** Licensee agrees to pay to Licensor the following amount per year for the removal of trash from the Licensed Premises: \$2,684.00 for the term commencing January 1, 2024 and terminating December 31, 2024; \$2,952.40 for the term commencing January 1, 2025 and terminating December 31, 2025; and \$3,247.64 for the term commencing January 1, 2026 and terminating December 31, 2026.

5. **Permitted Uses of the Licensed Premises:** It is agreed that during the hours stated in this License the Licensed Premises will be used solely by the Atlantic County Nutrition Project under a federally funded program and that the meals will be served only to senior adults as permitted by this Program. The Licensor shall provide sufficient chairs and tables to permit meals to be served to 135 persons each day. Licensee may also provide programs specified under the Older American Act.

6. **Dangerous Materials; Exception For Authorized Training Materials:** Neither party shall keep or have on the Licensed premises any article or thing of a dangerous, inflammable, or explosive character that might unreasonably increase the danger of fire on the Licensed area or that might be considered hazardous or extra hazardous by any responsible insurance company.

7. **Warranties:** Licensor hereby warrants that the Licensed Premises is safe and fit for Licensee's intended purpose of operation.

8. **Compliance With All Laws:** Each party shall be solely responsible for obtaining any and all governmental permits, approvals or other consents necessary to carry on any work or activity upon or within the Licensed Premises, at the party's sole cost and expense. It shall be the responsibility of each party to insure that all activities and uses of the Licensed Premises shall be performed in conformance with all applicable Federal and State laws, County ordinances and regulations.

9. **Assignment and Subletting:** Neither party shall assign this License, or sublet or grant any concession or license to use the premises or any part thereof. A consent by either party to one assignment, concession, or license shall not be deemed to be a consent to any subsequent assignment, subletting, concession or license. An assignment, subletting, concession, or license without the prior written consent of the other party, or an assignment or subletting by operation of law, shall be void and shall, at the party's option, terminate this License. The Licensor recognizes that the Licensee contracts annually for site manager services and that the right to occupy the premises extends to County employed and contracted site managers.

10. **Insurance and Indemnification:**

A. Each party agrees to indemnify the other and their officers, agents and servants from any and all losses, claims, actions, costs, expenses, judgments, subrogation, attorney fees or other expenses which may arise by reason of any real or alleged injury or damage to the person or property of others arising out of or incidental to its responsibilities under the terms of this Agreement, to the extent caused by the negligent acts or omissions of its officers, employees, agents or contractors.

B. Each party shall maintain proper insurance covering all risks associated with the operations contemplated by this Agreement. Such coverage may include a duly authorized self-insurance program. Each party shall additionally ensure that its agents, contractors and professional staff shall maintain proper insurance covering all risks associated with the operations contemplated by this Agreement.

C. Nothing herein shall be deemed to create any rights or afford any privileges to third parties. Nothing herein shall be deemed to waive, limit or abridge any rights, obligations or defenses that may arise under the provisions of the New Jersey Tort Claims Act.

11. **Termination of the License:** In addition to immediate termination for a failure to provide or maintain required insurance coverage pursuant to Section 10 above, either party may terminate this License:

A. If the other party persistently disregards laws, ordinances, rules, regulations or orders of a public authority having jurisdiction.

B. If a party is guilty of a substantial breach of any provision of this Agreement.

C. If either party, in its sole judgment and discretion, determines that its use of the

Licensed Premises conflicts or shall conflict with all applicable Federal and State laws, County ordinances and regulations.

D. The County may also terminate this License, in whole or in part, if funding for the intended purpose is no longer available to the County.

E. Either party may terminate this license, without cause, by giving sixty days written notice of such termination, and at the end of the sixty days the Licensee shall vacate the premises.

12. **Default and Remedies:**

A. **Default.** A default under the agreement shall include but not be limited to any of the following events:

1. Bankruptcy or insolvency of Licensee, whether liquidating or non-liquidating;
2. Breach of any term of the Agreement by either party.
3. Abandonment of the Atlantic County Nutrition Project by the Licensee;
4. Failure of the Licensee to make payments to the Licensor that are lawfully due and owing under this Agreement, provided that such payments are not subject to any other reasonably valid offset, lien, claim or demand.
5. Assignment or subcontracting of the work or any part thereof or any monies due hereunder that is not authorized by the County as set forth in this Contract.

B. **Remedies:** In the event of a default, the non-defaulting party shall be entitled to proceed with each and every remedy that may be available at law or in equity, including but not limited to: commencement of an action seeking specific performance, damages, and termination of this agreement as provided in Section 11 herein. The commencement of any rights or remedies by either party shall not be deemed to preclude any other rights or remedies that may be available to such party.

Prior to commencement of any right or remedy pursuant to this section, the party alleging a default shall provide the defaulting party with written notice and an opportunity to cure, which shall in no event extend beyond 30 days from the date of the alleged default's occurrence.

13. **Holdover by Licensee:** There shall be no "hold over" occupancy or month to month extension. At the end of the term or sooner termination, Licensee shall cease use and occupancy of the Licensed Premises.

14. **No Waiver of Rights:** Any waiver by either party under this License or of any breach by the other party shall not affect similar rights subsequently arising, nor operate as a waiver of subsequent breaches of the same or similar kinds, nor as a waiver of the clause or condition under which said right arose or said breach occurred.

15. **Surrender of Premises:** At the expiration of the License term, or upon Termination of this License, Licensee shall quit and surrender the premises hereby demised in as good state and condition as they were at the commencement of this License, reasonable use and wear thereof and damages by the elements excepted.

16. **Removal of the Licensee's Property:** Any equipment, fixtures, goods or other property of the Licensee or its agents, members or invitees, not removed by the Licensee after the date of the termination of this License, or upon any quitting, vacating or abandonment of the premises by the Licensee, shall not be considered as abandoned. 

An ordinance to exceed the municipal budget appropriation limits and to establish a CAP Bank (N.J.S.A. 40A:4-45.14)

WHEREAS, , the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and

WHEREAS, the Township Committee of the Township of Egg Harbor in the County of Atlantic finds it advisable and necessary to increase its CY 2024 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and

WHEREAS, the Township Committee hereby determines that a 1% increase in the budget for said year, amounting to \$383,867.69 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and
