§225-88 Zoning permits required. No person hereafter shall erect, construct, locate or alter any building or portion thereof or begin or change the use of any building or land without first obtaining a zoning permit therefor from the Zoning Officer. All applications for zoning permits shall be in writing and shall be addressed to the Zoning Officer, shall be **signed by the owner of record or designated agent**, (i.e., New Jersey licensed architect, engineer, land surveyor or building contractor), shall be made on such forms as may be prescribed and furnished by the Township and **shall contain all information called for by such forms and be accompanied by such plans as may be required**, together with any additional information that may be requested by the Zoning Officer, in order to determine whether the proposed construction location, construction or alteration of a building or the proposed use or change of use of land or building will comply with the terms and provisions of this chapter or lawful order of the Planning Board of a site plan or minor site plan applications failing to comply with the provisions of the Code shall be rejected and written notice, stating the grounds of rejection shall be given to the applicant. All applications filed, together with the accompanying plans and documents, shall be public record. Any zoning permit issued hereunder shall be subject to the fulfillment of all conditions imposed by the Board of Adjustment or the Planning Board.
