



DETERMINATION OF NONSIGNIFICANCE (DNS)

MUKILTEO INTERIM COMMERCIAL PARKING LOT

FOR PORT OF EVERETT

SEPA No. 2022-08

The Port of Everett has completed an environmental analysis, including review of pertinent and available environmental information, and a completed Environmental Checklist for the following proposal:

PROPONENT AND LEAD AGENCY:

DESCRIPTION OF PROPOSED ACTION:

Change of use for the site to allow for an interim commercial parking lot. The lot will provide approximately 99 parking spaces including four (4) ADA accessible spaces. Site work to include basic maintenance activities, sealcoating, restriping, and adding planter boxes to convert the former ferry holding lanes to an interim commercial parking lot.

A more detailed description of the proposed action is included in the Environmental Checklist.

LOCATION:

The subject property is a 0.89-acre parcel located in Mukilteo. The property address is 707 Front Street, Mukilteo, WA 98275, and is identified as parcel 00451300100100 by Snohomish County. The property is located within Township 28 North, Range 4 East, Section 4, WM.

Approximately half of the north section of the property is located within the Urban Waterfront shoreline designation under the City of Mukilteo Shoreline Master Program. The property is bordered on the north by Front Street and to the south by State Route 525. The property is bordered to the west by Mukilteo Speedway and to the east by an existing surface parking lot and Park Avenue.

DETERMINATION:

This environmental evaluation has been conducted in accordance with the provisions of the Washington State Environmental Policy Act (SEPA) under Chapter 42.31C, Revised Code of Washington (RCW), Chapter 197-11, Washington Administrative Code (WAC), and Port of Everett Resolution No. 614, SEPA Policies and Procedures. As lead agency, the Port has determined that the proposal will not have a probable significant adverse impact on the environment. Therefore, an environmental impact statement (EIS) is not required under RCW 43.21C.030(2)(c).


