Fairport Bicentennial Canal Gateway Project

The Village recently completed significant improvements to the canal bank southwest of the Liftbridge. Amenities include a new road surface, sidewalks, lighting, non-motorized boat mooring, pedestrian docks, observation decks and much more.

A ribbon cutting was held mid-September to celebrate the increased use and impact the Erie Canal has on our community.



A similar project will be taking place on the northwest bank starting this November. Improvements will include replacement of the existing boat docks that will be directly accessible from the canal path, new lighting and utilities, accessible kayak and canoe facilities, rehabilitation of the existing train depot structure and a complete rebuild of Liftbridge Lane West. This street will become one-way for vehicular traffic and have designated pedestrian and bike lanes.

Fairport understands the importance of the Erie Canal and our desire to have active transportation options and increased walkability in our community. **Fairport on the Rise!**



Fairport Farmer's Market

Thank you to Farmers Market Manager, Fritz May, for guiding the Fairport Farmers Market through its 47th successful season. While COVID-19 delayed the opening date and changed some of the market rules, it couldn't stop our farmers from delivering

plants, fresh produce and locally made products. Fritz, is completing his 30th year as Market Manager. Congratulations Fritz. Make sure you get out to the market for the last few weeks of the season. The last day of the market is scheduled for Saturday, November 21st.

Direct Current Fast Charging Stations

The New York Power Authority (NYPA) and Fairport Electric will be installing two Direct

Current Fast Charging stations at 260 Fairport Village Landing as part of the EVolve NY program. Construction is expected to start the week of October 26, 2020 with completion targeted for mid-November.

The units, which will be the first vehicle agnostic fast chargers to serve the Rochester region, will be able to charge a car in 15-30 minutes.

The site will be the first installed by NYPA for one of its municipal electric utility customers. The Village of Fairport receives low-cost hydropower from NYPA through its municipal electric partner Fairport Electric which

allows electricity for driving to be lower priced and generated from renewable resources.

NYPA has previously cited the Village of Fairport for the high number of alternative transportation vehicles added to its municipal fleet since 2016. Last year, the Village was designated as the first EVolve NY electric vehicle accelerator community, a local initiative that will encourage the adoption of EVs by installing both home charging stations and public chargers in the community. The project will also work to improve the community's perception of EVs through

education and engagement efforts.

Lessons learned in Fairport will be shared with other communities statewide as a blueprint for encouraging widespread EV adoption throughout the state.

The Department of Public Works will be collecting bulk leaf piles starting in October and continuing through December, weather permitting. Bulk collection will be suspended or delayed upon the first significant snowfall.

DPW crews will make every attempt to pick up your leaves on the day of your scheduled refuse collection, however during peak leaf collection periods the collection days may vary. During these times, crews start at the beginning of the route and continue until all leaves have been collected. This may result in your leaves being picked up a day early or late.

To assist the DPW in leaf collection, the following tips are offered:

- All leaves must be placed in the tree lawn area for collection (between the sidewalk and curb).
- Leaves should be placed in one pile parallel to the street in a location Village equipment can access.
- Do not place leaves near any obstructions such as trees, street lights, etc.
- Ensure that leaf piles are free of sticks, rocks, and other debris that may damage leaf collection
- y Small piles (should be placed in containers less than 2 to 3 cans). Small loose piles will not be collected.
- During the spring, leaves should be placed in containers. Large piles will be picked up with a loader. DPW at (585) 223-9500.

Snow Removal

As winter is quickly approaching, the Department of Public Works (DPW) has several tips to assist with snow removal operations.

Please note there is **no** parking on Village streets from 3:00 AM to 7:00 AM November 1st through April 1st.

- Residents clearing snow from sidewalks and driveways should move snow only to locations on their own property.
- Snow should not be shoveled or plowed onto side walks, across the street, or left in the street. Homeowners should direct plow contractors to abide by the same rules.
- Village sidewalk plows will clear snow throughout the winter; please do not block public sidewalks in any way.
- * Help mail carriers by keeping sidewalks clear of snow in front of homes and mailboxes.
- * Assist the Fire Department by keeping nearby hydrants clear of snow in the event of an

Thanksgiving: Thursday residential refuse collection scheduled for November 26th and Friday commercial refuse and recycling scheduled for November 27th will be collected Wednesday, November 25th.

Christmas: Commercial refuse and commercial recycling collection scheduled for Friday, December 25th will be collected on Thursday, December 24th.

New Years Day 2021: Commercial refuse and commercial recycling collection scheduled for Friday, January 1st will be collected on Thursday, December 31st.

Good Friday: Commercial refuse and recycling collection scheduled for Friday, April 2nd will be collected on Thursday, April 1st.

Bulk Refuse and Yard Waste Collection: From April - November bulk waste is collected every week. From December - March bulk waste is collected as weather and operations allow. No contractor debris will be collected and bulk waste piles should not exceed 4 ft. high by 4 ft. wide by 8 ft. long.

Fairport Office of Community + Economic Development (OCED) Grant Programs

Senior Disabled Home Improvement Grant:: OCED offers grants to income-eligible seniors and disabled homeowners for emergency, essential or safety-related home improvements or repairs which include heating, plumbing, electric, roofing, windows, doors, and insulation.

FRONT PORCH GRANT: This incentive program provides a matching grant for front porch preservation, restoration, or rehabilitation projects. Eligible properties: Residential properties located in the Village of Fairport (Property class 210, 220 and 230) which are owned by Village residents. To be eligible for consideration, the project must not yet be permitted or under construction. Routine maintenance is not eligible.
