Dustin Ward was sworn in as a member of the Fayetteville Fire Department.

### Reports:

### Fayetteville/Lincoln County Chamber of Commerce:

Carolyn Denton, Fayetteville/Lincoln County Chamber of Commerce Director, reported that the 31<sup>st</sup> Annual Host of Christmas Past was a great success with great attendance and more than fifty (50) vendors. Ms. Denton expressed her appreciation to the many people who helped make the event possible. Hamburger Day on the Hill is scheduled for March 27, 2024. The new fiscal year for the Chamber began in October and was celebrated by the annual banquet. The new officers are President Erica Smith, President-Elect Shannon Neal, Treasurer Jason Hambrick, Secretary Mary Beth Seals and Past President Erin Mills. ## **Fayetteville Main Street:**

Aimee Byrd, Fayetteville Main Street Director, stated that the 2023 "First Saturday's" concluded with the October event. There have been eight (8) "Confetti Pop" events to recognize new businesses, relocations of current businesses, new owners and/or business anniversaries. Two hundred two (202) of the courthouse ornaments have been sold to date. Main Street's co-workspace is now open with five (5) micro offices, three (3) of which are already booked. Main Street received a fifteen thousand dollar (\$15,000) grant from Launch Tennessee to supplement the food and beverage program. In total, forty thousand dollars (\$40,000) has been received in grants to support food and beverage in our community. Spirits with the Spirits was successful with sixty (60) tickets sold. Over four hundred dollars (\$400) was raised for cemetery

restoration. We were not selected to receive the Downtown Improvement grant. Main Street's New Years Eve celebration will be at the Museum with the band Midnight Jane playing from 9:00 pm until midnight. The 2024 Slawburger Festival is scheduled for April 20<sup>th</sup>.

## **Lincoln County Emergency Management Agency:**

Doug Campbell, Lincoln County Emergency Management Agency (EMA) Director, on behalf of the EMA/Fire Committee of Lincoln County, read and then presented Chief Tony Kimbrough with the following letter of appreciation:

### Fire Report:

Chief Tony Kimbrough reported that in the month of October 2023 the Fayetteville Fire Department responded to one hundred twenty-one (121) calls for service to include one (1) fire, one hundred (100) EMS assists, and seven (7) motor vehicle accidents.

## **Police Report:**

Chief Barry Pendergraft reported that the Fayetteville Police Department responded to seven hundred ninety-eight (798) events in the month of October 2023 to include forty-five (45) traffic accidents with five (5) injuries, made twenty-seven (27) arrests and issued thirty-six (36) traffic citations for fifty-three (53) violations.

## **Finance Report:**

Loretta Garner, Finance Director, reported that the software conversion from eGov to Local Government is nearing completion. The credit card readers have been installed and we are currently accepting card payments. Local option sales tax collected for the month of September decreased, but indications are that October is looking to rebound. The occupancy tax collected has also decreased at a rate of one to two percent (1-2%) per month.

#### **Recreation Report:**

Nathan Browning, Parks and Recreation Director, reported that the Farmers Market roof has been repaired. The Christmas lights have been installed with some additions. We are working to obtain quotes for the tennis/pickleball courts at the Recreation Center. Our recent Trunk or Treat event held at Stone Bridge Park was a big success. Applications to be in the Christmas Parade are being accepted. We are reimplementing policies whereby a rental fee will be charged for the use of the baseball or softball fields outside of the City leagues or scheduled events. Athletic boards have been established for baseball, softball and soccer. We continue to work on improvements to the gun range. We are working closely with Fayetteville Public Utilities to get electric power run to the new scoreboard at the soccer field. Lastly, we continue to look for the best location to install the Veterans of Foreign Wars (VFW) bricks to recognize and celebrate our local veterans.

## Public Works Report:

Eddie Plunkett, Public Works Director, reported that one hundred thirty-nine (139) tons of brush, fourteen (14) tons of leaves, and two hundred fifty-three (253) tons of trash were collected for the month of October.

# Planning and Codes Report:

Kristi Gentry, Planning and Codes Director, reported that thirteen (13) permits were issued and two thousand, fifty-six dollars (\$2,056.00) in permit fees were collected for the month of October 2023. The total project valuation was six hundred thirty-one thousand, nine hundred six dollars (\$631,906.00). Work has ceased on the old Taco Bell building as the existing structure has been determined to be unsafe. There were forty-eight (48) property violations issued for the month of October. At the October Planning Commission meeting, officer elections were held with Jim Donaldson being elected Chairman, Craig Carmichael was elected Vice-Chairman, and Dr. Mike Harry was elected Secretary. Director Gentry then extended a thank you to all that were involved in helping to make the Host of Christmas Past a great event.

#### **City Administrator's Report:**

Kevin Owens, City Administrator, provided his monthly report to the Board of Mayor and Aldermen. Work is beginning on the 2024-2025 budget preparations. We are awaiting news of the multimodal grant recipients, hoping to hear sometime in the month of November. Staff members continue to work on morale

issues throughout the City and will be working throughout until January 1<sup>st</sup> towards getting the animal control services to full service. Currently we are doing emergency services only. The contractor has executed the contract for the sidewalk project; therefore, we will be announcing a preconstruction meeting date soon.


