REGULAR MEETING BOARD OF MAYOR AND ALDERMEN JANUARY 10, 2012

REFERENCE VIDEO DATED JANUARY 10, 2012

The Board of Mayor and Aldermen of the City of Fayetteville, Lincoln County, Tennessee, met in open, public session at the regular meeting place of said Board in the Municipal Building of said City at 5:00 p.m. on January 10, 2012. Mayor John Ed Underwood, Jr., was present and presiding. The following named Aldermen were present:

Approval of Minutes:

Reports:

Swim Team:

Dawn Dixon, representing the local swim team, asked for the City to consider building a new swimming pool for the swim team, as well as for the community.

Industrial Development Board Update:

Larry Craig, Industrial Development Board Chairman, discussed the various renovation projects on the "Posey House", located in the Posey Industrial Park. Mr. Craig explained that the Industrial Development Board (IDB) should receive a grant from the State Department for Two Hundred Fifty Thousand Dollars (\$250,000.00), for the construction of the sewer system in the Posey Industrial Park. Mr. Craig stated that the grant would only pay for a portion of the sewer system and the IDB would be asking the City and County Governments to split the additional cost of the system.

Entrepreneur Program:

Dan Marcum, of Nest-TN, discussed how the TNInvestco Program is a program to help technology entrepreneurs with start-up money in the Fayetteville/Lincoln County Area.

FPU Report:

Britt Dye, CEO of Fayetteville Public Utilities, explained that the water/waste water department is working to replace the water tanks at the E911 Center and the Howell Community. Mr. Dye stated that the water/waste water division is relocating the Biosolids to a new approved disposal site. Mr. Dye stated that the 3-phase work, for the B & W Grows, located on 64 Highway East, has been completed. The telecom department has signed-up ninety (90) new customers during the month of December.

Fire Report:

Fire Chief Danny Travis reported that the Fire Department had 75 calls for service with 46 medical calls, 2 motor accidents with injuries and 1 vehicle fire with an estimated loss of One Hundred Dollars (\$100.00).

Police Report:

Police Chief Doug Carver reported that there were 103 incidents with 65 arrests, 42 crashes and 45 citations for a total of 1,708 events.

Public Works:

Eddie Plunkett, Public Works Director, reported that 246 tons of residential trash was picked up, along with 192 tons of yard waste for the month of December. Mr. Plunkett stated that Public Works would be closed for the Monday, January 16, 2012, for the holiday. Mr. Plunkett explained that Monday's garbage route would be picked up on Tuesday.

Recreation Report:

Rickey Honey, Recreation Director, stated that softball and baseball sign-ups are in progress. Mr. Honey explained that there will be a bid opening on January 17, 2012, for the work to be done on the waterway at Stone Bridge Park. Mr. Honey stated that they are preparing two ball fields for the City high school baseball team.

Planning and Zoning Report:

Ryan Tyhuis, City Planner, reported that for the calendar year of 2011 there was a total of two hundred eighty-two (282) violations issued with two hundred forty-five (245) complied/closed, seven (7) fined or charged court cost in municipal court, four (4) dismissed with compliance, eight (8) lots were cleaned by public works or the recreation department, and seven (7) case administratively closed. For the month of December, there were a total of seven (7) building permits issued for approximately Three Hundred Sixty

Thousand, Nine Hundred Dollars (\$360,900.00) in work to be done, with the fees being One Thousand, One Hundred Seventeen Dollars (\$1,117.00).

Administrator's Report:

Mr. Lee stated that Tennessee Department of Transportation has made some adjustments to the contract for the signalization of the traffic lights and the contract is ready to be signed. Mr. Lee explained that the auditors are here and their report should be ready by the middle of February. Mr. Lee stated that the survey work on the Biosolid field should be completed by the middle of January.

Resolution R-12-01:

<u>Resolution R-12-01</u>, a resolution entitled "A Resolution Of The Board Of Mayor And Alderman Of The City Of Fayetteville, Tennessee Approving To Submit For Funds For The Tanyard Branch Basin Sewer System", was considered. Said Resolution is as follows:

CITY OF FAYETTEVILLE RESOLUTION NO. R-12-01

A RESOLUTION OF THE BOARD OF MAYOR AND ALDERMAN OF THE CITY OF FAYETTEVILLE, TENNESSEE APPROVING TO SUBMIT FOR FUNDS FOR THE TANYARD BRANCH BASIN SEWER SYSTEM

WHEREAS, the City of Fayetteville, Tennessee is eligible for funds under the State of Tennessee "Small Cities" Community Development Block Grant Program; and

WHEREAS, there exists a need to rehabilitate the Tanyard Branch Basin area of the Fayetteville Public Utilities sewer system; and

WHEREAS, the City of Fayetteville wishes to make an application for said project;

NOW, THEREFORE, BE IT RESOLVED, THAT

- (1) The Mayor be authorized and directed to execute and submit an application for funds to the Tennessee Department of Economic and Community Development in the amount of \$450,000.
- (2) The Mayor be authorized and directed to enter into all necessary agreements to receive and administer such grant funds.
- (3) The total cost of the project is \$584,416. The balance of \$134,416 in local matching contribution will be provided by funds from the Fayetteville Public Utilities.
