Reports:

Fayetteville-Lincoln County Chamber of Commerce:

Carolyn Denton, Chamber Director, reported that the Chamber and Main Street were going to present a joint report for this months' meeting. Presentations were presented to the Host of Christmas Past committee in appreciation of their efforts in this year's Host of Christmas Past Event. It would not have been a success without all of the efforts from the numerous departments of the City.

Camp Blount Historic Site Association:

President Randy Delap reported that the association has been awarded 501(c)(3) tax exempt status. Special thanks to Attorney Johnny Hill for assisting the group this for Camp Blount. The purpose of this committee is to help raise funds for Camp Blount, memberships and to apply for grants. Dr. Farris Beasley reported on the history of Camp Blount and the significance of the term "Volunteer State."

Fire Report:

Fire Chief Danny Travis reported that there were 100 calls for service, with a loss of \$13,217.00. There were 69 medical calls and the volunteers logged 128 hours. During Fire Prevention month, the fire department came into contact with 524 children and 144 adults.

Police Report:

Police Chief Richard Howell was in training and no report was given.

Recreation Report:

Chris Mitchell, Recreation Director, reported that Halloween Happenings was October 24th and a good crowd was present. There is a new Christmas light display at Stone Bridge Park. Brad Bolles has been hired as the new recreation attendant. The Annual Christmas Parade will be December 2, with a theme of "Peace on Earth."

Public Works:

Eddie Plunket, Public Works Director, reported that 365 tons of brush was collected, 231 tons of sanitation, and 23 tons of leaves was collected. The Public Works Department will be closed November 23rd and 24th for the Thanksgiving holiday. The garbage trucks will run the Friday morning. The leaf machines are running daily to gather the leaves. City residents are asked not to bag their leaves.

Planning and Codes Report:


