Reports:

Fayetteville Lincoln County Library:

Bernadette Roche, Library Director was very excited to report the Library excels in service to the community. There have been 34,042 visitors, 254 programs with 2,603 persons in attendance. The library has loaned 54,329 items to the public. Also, the library offers free use of computers, Wi-Fi and internet. During 2018, the library provided access to Tumble Books to the city and county school systems, with generous assistance from the Junior Round Dozen. The summer reading program is an outstanding commitment to the community. The library has sponsored an angel tree to benefit Donaldson Care Center and Skills Development, and the community has responded generously. Director Roche welcomed businesses to partner with the library.

Fayetteville Public Utilities

Britt Dye, CEO introduced the employees that volunteered to go to North Carolina and Georgia to complete disaster repairs from the area disasters. The FPU crews are very knowledgeable and they start work fast and get the jobs done, without any major accidents. Mayor Whisenant thanked all of the volunteers for their hard work for our community.

Fire Report:

Fire Chief Coby Moon presented the fire report. Chief Moon reported that there were 79 calls for service, 60 medical calls, 2 motor vehicle accidents with injuries, and 1 structure fire with approximately \$10,000.00 in losses to report. The average response time was 2:53 in the city limits. Chief Moon said that the annual toy drive is gearing up and will be helping 265 families and 580 children. The Fire Department partners with the Elk Valley Times and the Rotary Club for this event. Applications can be picked up at the Elk Valley Times, and the tentative date that toys will be distributed is December 21, 2018.

Police Report:

Police Chief Richard Howell presented the police report. Chief Howell reported that there were 102 reportable incidents to the TBI, 52 arrests, and they issued a total of 66 citations. The total police activity events were 1,384. The Titan system was down so Chief Howell could not get the number of accidents that were investigated for the month of November.

Recreation Report:

Chris Mitchell, Recreation Director, would like to thank all of the departments involved in setting up the light display at Stone Bridge Park. Miracle is still completing the repairs at Kid's Park. The annual Christmas parade was a huge success this year.

Public Works:

Eddie Plunkett, Public Works Director reported that 18 ton of leaves and 20 loads were taken to the community garden. There were 87 tons of brush and 253 tons of trash collected for the month of November. The Public Works Department will be closed December 25 and January 2 for the Christmas and New Year's holiday. All trash that is normally picked up on those scheduled days will be collected on the following day. Mayor Whisenant thanked Director Plunkett for helping out at the recycle center and the lights display.

Planning and Codes Report:

Kristi Gentry, Planning and Codes Coordinator, reported that 6 permits were issued, with permit fees being \$660.00, with a total project evaluation of \$156,325.00. There have been 715 violations issued and approximately 75%-85% of those have been resolved.

Administrator's Report:

Scott Collins, City Administrator, reported that Phase II of the Greenway project will have funds committed by July 15th. Travis Rael is working diligently to get the information to TDOT to sign off on and the engineers are moving ahead with the schedule. Everything is back on track and moving along well. This month will have a bid package together for William D Jones and it is on schedule. A fact finding tour will be held at Ninth Grade Academy to determine its feasible for a future recreation center. The Camp Blount committee met with a statue designer today and was very impressed with the work that was presented. Lincoln Leadership will be at the Municipal building on December 13th for their annual informational meeting. The Phase I Greenway bid package is ready to be submitted, pending approval from the feds.
