The Board of County Commissioners of Fillmore County, Minnesota met in special session this 26th day of February, 2019 at 9:00 a.m. in the Commissioners' Board Room, Fillmore County Courthouse, in the City of Preston.

The following members were present: Commissioners Duane Bakke, Marc Prestby, Randy Dahl, and Mitch Lentz. Wayne Sandberg, President of the Minnesota County Engineers Association, gave a presentation of the Project of the Year to Fillmore County Highway Department. Ron Gregg gave a presentation on the Project Selection Criteria for Fillmore County and reviewed the process used to select projects in the County.

The Citizen's Input portion of the meeting was opened and closed at 10:17 a.m., as no one was present to speak.

The Chair recessed the meeting at 10:17 a.m. and resumed back in session at 10:25 a.m.

Commissioners Bakke and Prestby gave the Highway Committee Report: road work on the Fish Hatchery road in Lanesboro will begin after the reconstruction of Fish Hatchery Administration Building; discussed other 2019 project designs and advertising for them; Bakke noted that he would like to see updates on 2019 projects monthly; Federal fund solicitation was discussed; Guardrail damage on County 1 that happened when the road was still gravel has been repaired; ice dam build up in the administrative building, which has water dripping in Surveyor's office; all buildings need to be looked at for issues due to the weather.

Drew Hatzenbihler, Solid Waste Administrator, was present.

On motion by Lentz and seconded by Prestby, the Board unanimously approved the 2019 Hauler's licenses.

Kristina Kohn, Human Resources Officer, was present.

On motion by Dahl and seconded by Lentz, the Board unanimously approved to hire temporary, part-time office support staff in Extension/Veteran Services as requested by the Veteran Services Officer and County Extension Educator as recommended by the Community Services and Extension Committees.

On motion by Prestby and seconded by Lentz, the Board unanimously approved the resignation request from Sherida Newgard, Accounting Technician, with Early Retirement Incentive package effective March 7, 2019 and thanked her for her 18 years of service to Fillmore County.

On motion by Prestby and seconded by Lentz, the Board unanimously approved to fill the open vacancy with current candidate pool for Accounting Technician as requested by the Auditor/Treasurer and as recommended by the Hiring Committee.

Bobbie Vickerman, County Coordinator, was present.

On motion by Prestby and seconded by Dahl, the Board unanimously approved the purchase of Civil Engineering Design Software called Softree for use in the Highway Department as recommended by Technology/Land Records/GIS.

On motion by Prestby and seconded by Dahl, the Board unanimously approved the replacement of the Barrier Firewall with Cisco Firewall units at both Courthouse and County Office Building as recommended by Technology/Land Records/GIS.

Bakke noted that the Personnel Committee met with Department Heads and the physical moves for Taxpayer Services have begun. It was stated that the Land Records and Zoning will be moving into the current Auditor/Treasurer space, the Auditor/Treasurer will move into current Assessor's space and Recorder will stay as is.

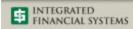

Consumer Support Grant program

The Consumer Support Grant (CSG) program replaces the Medicaid home care services of home health aide (HHA), personal care assistance (PCA) and home care nursing (HCN) with a state-funded grant. Participants work with their county or tribal agency to develop a person-centered, county-approved plan to manage and pay for a range of supports so they may live in their home.

The program gives consumers greater flexibility and freedom of choice in how they get their supports and services as well as who provides them. They may hire parents, spouses, family members, trusted neighbors or friends as well as employees of traditional home care provider agencies.

Who is eligible for a CSG?

To be eligible for a CSG, a person must meet all of these criteria:

- Be eligible for Medical Assistance (MA)
- Be assessed for HHA, PCA or HCN services
- Be able to direct and purchase their own care and supports or have a family member, legal representative or other authorized representative direct and purchase their care and supports on their behalf
- Have a functional limitation that requires ongoing supports to live in the community
- Live in a home setting
- Not receive services through:
 - MA managed care (except Special Needs BasicCare)
 - A home and community-based waiver
 - Family Support Grant
 - Alternative Care
 - MA home care services (HHA, HCN or PCA).

How do people receive the grant?

The county or tribal agency will assess the person's needs and help develop their CSG service plan. The plan:

- Identifies the supports the person needs
- Outlines how CSG will pay for those supports
- Describes the method for documenting the person's expenses.

CSG participants must:

- Arrange for purchasing their goods and services
- Document all CSG expenditures
- Hire a fiscal support entity to help with employer obligations, billing and payment functions.

The county or tribal agency approves the plan and ensures that all costs are within the person's CSG budget.

How much can a person receive?

The grant amount is based on the person's home care assessment and rating, available program funding and state budget caps. Individuals can obtain an estimate of their grant from their county or tribal CSG coordinator. In state fiscal year 2017, an average of 2,382 participants per month received an average monthly grant of \$967.

What can CSG pay for?

A CSG participant may purchase a variety of supports that are included in their person-centered, countyapproved plan. All goods and services must:

- Relate to the person's functional limitations
- Help them live in their own home
- Be over and above the cost of supporting a person without a disability.

County or tribal agencies may customize the CSG program within state guidelines to fit the needs of their residents. People should contact their local agency for more information.

Examples of allowable expense categories may include:

- Companionship services
- Chore services
- Family counseling
- Home or vehicle modifications
- Nutrition services, home delivered meals
- Respite care
- Home health aide or personal care-like services
- Home care nursing services
- Specialized equipment
- Transportation.

People must use all other available sources of payment before using the CSG.

How can people apply for the grant?

People may apply at their local county or tribal agency. Currently not all counties offer CSG. However, people may contact them with questions about the CSG.
