



## **CONFLICTS OF INTEREST & DISCLOSURE OF CERTAIN RELATIONSHIPS WITH LOCAL GOVERNMENT OFFICERS**

### **CONFLICT OF INTEREST**

**Chapter 171** of the **Texas Local Government Code** provides for the regulation of Conflicts of Interest of Officers of Municipalities, Counties, and certain other Local Governments. As a City Official, you are subject to the conflict of interest provisions set forth in this Chapter. Part of your responsibility under this Chapter would be to file an affidavit and abstain from voting on items that you may have a substantial business interest in. You may file the affidavit with the Office of the City Secretary. Please be sure to read Chapter 171 carefully so you are familiar with the requirements. ### **DISCLOSURE OF CERTAIN RELATIONSHIPS WITH LOCAL GOVERNMENT OFFICERS; PROVIDING PUBLIC ACCESS TO CERTAIN INFORMATION.**

**Chapter 176** of the **Texas Local Government Code** provides for the necessity of a local government officer to file a Conflicts Disclosure Statement in certain situations. It also provides for the necessity of vendors to file a completed conflict of interest questionnaire if the vendor has a business relationship with a local government entity. Chapter 176 requires that the documents responsive to this section be public and require that local government entities post the documents on their website.
