He believed that home ownership was the backbone of any community and anything that the City could do to encourage home ownership was valuable. He disliked seeing a community occupied with mobile homes because that was an inexpensive approach to select. He wanted homes built within the city to encourage people to remain locally. He disliked seeing homes that were only one block outside city limits to avoid paying for city property taxes and abiding with City regulations.

The City could "afford" this homestead exemption at this time and asked Council Members to authorize it for citizens.

5. Code Enforcement Officer Ingles ---

➡ Ord. No. 09-121; Sec. 12-7. Illegal Dumping; Adopted 07/14/2009;
It shall be considered illegal dumping for anyone residing inside or outside the city limits that does not pay for City sanitation services to dispose of their garbage or refuse in any City-Owned receptacle. A fine shall be assessed in accordance with the City's Code of Ordinances.

Code Enforcement Officer Ingles provided an update on the revision(s) made to bulk trash in October 2017 and focused on details regarding illegal dumping.

She reported that the Department was intently focusing on the illegal dumping that some of the county residents were doing. Numerous reports were received that these residents were entering the city and allegedly dumping their trash in city receptacles. This was not only a major violation of the City's ordinance but the Texas Health & Safety Code.

The county lacked a structured sanitation system and options for some of these residents were to either obtain a city receptacle and pay for this service or keep their money to illegally dump in the city. Possibly a plan could be prepared with Pecos County to deter this. The Department would continue to monitor violations, respond to calls & complaints in an attempt to discourage this in the future.

MINUTES OF LAST MEETING:

Code Enforcement Officer Ingles reported that this amendment clarified that recreational vehicles would not be allowed to park on city streets for longer than 72 hours. Several were currently parked on streets &/or parked extremely close to the alleyways which created issues for City crews in their daily operations. There were also intersections where recreational vehicles had been parked for lengthy periods and fairly close to stop signs & intersections which obstructed the view for drivers and was a safety precaution. Some were also parked close to fire hydrants which could be a hazard if a fire occurred.

The average weight of a recreational vehicle was 5,200 lbs. The life of city streets would extend if this extra weight was prevented for an extended period of time.

The side and back yards of a residence were options for parking recreational vehicles while the front yard was explicitly prohibited in the ordinance. Also, individuals from several of the R.V. Parks indicated that they could provide storage for a monthly fee or rent a spot. Nevertheless, an area in the county could be considered.

Prior to enforcement of the ordinance, the Department planned to provide a reasonable amount of time for adjustments to be made by owners of vehicles.

Council Member Falcon expressed that several conversations occurred throughout the years regarding this homestead exemption but the economy overruled this. In the past two years, the City was "blessed" with Blue Ridge and if this exemption was approved, the budget would be impacted on October 1st by approximately \$120,000.

City Manager Rodriguez reported that in considering the budget, the only item that required consideration was the health coverage. If an exemption was granted, the proposed budget would need to be revised.

Director of Finance Rodriguez provided homestead exemption examples for homes valued from \$80,000 - \$350,000. In considering an \$80,000 home:

- Option 1 1% = The minimum was \$5,000 and every property owner qualified for this amount unless the value of a house exceeded \$500,000. This Option granted \$355.13 or a \$23.68 yearly savings;
- Option 2-20% = An exemption of \$303.04 or a \$75.76 yearly savings;
- Option 3 10% = An exemption of \$340.92 or a \$37.88 yearly savings.

Several years ago, the City approved an exemption for Over 65/Disabled/Disabled Veterans which impacted the City by \$44,882.78 yearly. Depending on the option selected, the City would be impacted in the 2018-2019 Fiscal-Year Budget by: Option 1 = \$40,292.03, Option 2 = \$127,899.19 or Option 3 = \$66,782.43.

Council Member Falcon reported that properties being considered for this inclusion were in the vicinity of Apache Elementary School. The difference between an "inclusion" and "annexation" were: An inclusion is an area that has been a part of the municipality (but not annexed) for at least the preceding 20 years and received municipal services, including police protection compared to a voluntary annexation which will receive municipal services once the annexation process is completed &/or the property is incorporated into the city limits.

His goal for the past 10 years was that all properties south of the interstate needed to be part of the city. There were several "pockets" within the city that were not incorporated and therefore property owners were not required to pay for City property taxes; yet reaped the benefits of the city. This was unjust for property owners in the city that were obligated to pay this tax.

The inclusion of all "pockets" within the city would be beneficial but currently only \$66,000 was budgeted for this process which required a survey of the area. His intent was to initiate this process once again. Thereafter, City Council could select which property(s) was/were next. The emphasis was to incorporate
