MINUTES OF: SPECIAL CITY COUNCIL MEETING

ROLL CALL WAS ANSWERED BY COUNCIL MEMBERS:

**Mayor Alexander** called the Special Meeting to order a 5:33 p.m. after declaring a quorum present.

**Council Member Hodges** gave the Invocation.

**Council Member Warnock** led the Pledge of Allegiance & Pledge to the Texas Flag.

**Mayor Alexander** read the Mission Statement:

**“The Mission of the City of Fort Stockton Municipal Government is to Promote & Value Public Confidence and Trust by the Accountable and Responsible Use of Community Resources; to Ensure Public Safety; Improve Public Services; Promote Local Recreation and Entertainment; and Generate Economic Development.”**

**RESOLUTION:**

1. Discuss/Act upon Resolution No. 21-105R, Approving the Official Canvas for the May 1, 2021 City General Election. (**Mayor**)

**Mayor Alexander** advised everyone that 945 votes were cast at the City General Election to **Elect One (1) Mayor & Two (2) Council Members to 2-year terms** each.
