1. Discuss/Act upon Clarifying the Acreage and Extending Deadline for Receiving Sealed Lease Proposals for Approximately 360 Acres of Land, more particularly described as:
 - All of Tracts 7, 8, 9, 10, Section 4, Block 2, Fort Stockton Irrigated Lands Company Land, Pecos County, Texas;
 - Tracts 33, 34, 35, 36, 37, 38, 39, 40, 41, 42, 43, 44, 45, 46, 47, 48, 49, 50, 51, 52, 53, 54, 55, 56, 57, 58, 59, 60, 61, 62, 63 and 64, Survey 5, Block 2, Fort Stockton Irrigated Lands Company Land, Pecos County, Texas. (City Mgr./City Atty.)

City Secretary Marina Cantu explained the original solicitation included property belonging to the New Landfill. Therefore, she requested permission to clarify the acreage. This would require the notice to be published in the newspaper, extending the bid opening to January 26, 2024.
