

ORDINANCE NO. 21-100

AN ORDINANCE OF THE CITY OF FORT STOCKTON AMENDING THE PERSONNEL POLICIES & PROCEDURES MANUAL OF THE CITY OF FORT STOCKTON, TEXAS; PROVIDING REVISION TO THE ORGANIZATIONAL CHART BY TRANSFERRING THE MUNICIPAL JUDGE FROM THE SUPERVISION OF CITY COUNCIL TO THE CITY MANAGER; CONTAINING A SAVINGS CLAUSE; AND PROVIDING FOR THE PUBLICATION AND EFFECTIVE DATE THEREOF.

WHEREAS, the proposed reconstruction in the City of Fort Stockton Personnel Regulations, as shown in the attached Exhibit "A" reflects the restructuring of City Administration in its Personnel Policies and provides greater flexibility in the management of the City; &

WHEREAS, City Council finds and determines that this proposed revision to the Organizational Chart is imperative for the City, a matter of necessity, and required at this time as set forth in Exhibit "A" and henceforth a part of the City's Personnel Policies & Procedures Manual.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FORT STOCKTON, TEXAS:

SECTION 1: The City of Fort Stockton Personnel Organizational Chart is hereby amended and included in the City of Fort Stockton Personnel Policies & Procedures Manual.

SECTION 2: If any provisions, section, exception, subsection, paragraph, sentence, clause or phrase of this ordinance or the application of same to any person or set of circumstances, shall for any reason be held unconstitutional, void or invalid, such invalidity shall not affect the validity of the remaining provisions of this ordinance or their application to other persons or sets of circumstances and to this end all provisions of this ordinance are declared to be severable.

SECTION 3: All ordinances or parts of ordinances inconsistent with the terms of this ordinance are hereby repealed; provided however, that such repeal shall be only to the extent of such inconsistency and in all other respects this ordinance shall be cumulative of other ordinances regulating and governing the subject matter covered by this ordinance.


SECTION 4: This ordinance shall become effective after its approval and adoption upon final reading and its publication pursuant to law.
