Special Note to Applicants:

- An entertainment permit is required for indoor and outdoor amplified and non-amplified entertainment on private property, **within our industrial, commercial, and historic districts.**
- **Any outdoor entertainment, on private property, within the historic (H1) district is limited to acoustic performances, with only an entertainer's voice and string instruments being amplified.**
- Once approved, the entertainment permit is only valid for the date of the proposed event.
- Businesses shall be permitted a maximum of eight (8) entertainment permits per calendar year. There shall be a minimum of fifteen (15) days between entertainment permits issued for the same location. A separate entertainment permit application must be submitted for each event and businesses within 250 feet of each other will not be approved for same day events.
- Failure to adhere to these special notes and the permit guideline requirements may result in revocation of an existing permit or suspension of future applications.

The applicant hereby certifies to the correctness of the information and agrees to comply with all codes of the Village of Frankfort. In the event of a conflict between the approved document and any building, zoning and fire codes, the owner or his agent is not relieved from the responsibility to conform to all applicable codes and ordinances. The granting of previous entertainment permits to the applicant or owner has not, in the past, resulted in the operation of an establishment which have created public or private nuisances or created other disturbances to the surrounding community, such that calls for services to the police department have been excessive to such an extent as to cause injury or property damage.
