3001-4000 = 9 cents per lb; 4001-5000 = 12 cents per lb; 5001-10,000 = 15 cents per lb;  
10,000 and over = 20 cents per lb, **plus \$65 costs \$40 JSF fee.**

Default Judgment \$25.00  
14-day Notice \$25.00  
License Suspension \$45.00  
Plus an additional 20% late fee after 56 days from issue date of ticket
