Flanked by the Stansbury Mountains to the west and the Great Salt Lake to the north, Grantsville boasts sweeping natural beauty and an elevation of approximately 4,260 feet.

Grantsville is experiencing a period of unprecedented growth, all while maintaining the small-town character that defines its identity. As the second most populous city in Tooele County, it is welcoming new residents and businesses at a rapid pace. The city is currently seeing over a billion dollars in new housing developments, reflecting strong demand and a bold vision for the future. This expansion is thoughtfully guided to support sustainable growth, enhance quality of life, and preserve the city's proud historical heritage.

Grantsville, Utah has a 2024 estimated population of 15,682, reflecting a 24.1% increase since 2020. With a median age of 27.9, the city is young and family-focused, supported by a high percentage of married households and larger family sizes. The median household income is \$97,216, with just 5.0% of residents below the poverty line. Education is strong, with 24.9% of adults holding a bachelor's degree or higher.

- Coordinate with developers, engineers, and contractors during project planning and construction.
- Serve as a key liaison between the City and Planning Commission, City committees, developers, engineers, contractors, and community members.
- Support and advise the Planning Commission and other City committees.
- Collaborate across departments to promote smart, sustainable growth.
- Offer guidance and information to the public on zoning, land use, and permitting processes.
