

The organizational meeting of the Greenville City Council was called to order by Clerk Rasmussen, in the Council Chambers, in the Municipal Complex located at 415 S. Lafayette Street, Greenville, Michigan 48838 at 7:00 p.m.

Councilpersons Present: Councilpersons Cunliffe, Lehman, Linton, Barrus, Moss, Johnson, and Scoby.

Councilpersons Absent: None

Others Present: City Manager Bosanic, Assistant City Manager Feazel, and Clerk-Finance Director Rasmussen.

1. The Pledge of Allegiance was led by Clerk Rasmussen.
2. The first order of business was the election of Mayor for the ensuing year.

Councilperson Moss MOVED: Councilperson Cunliffe be nominated for Mayor.

Councilperson Scoby MOVED: Councilperson Lehman be nominated for Mayor.

Councilperson Lehman MOVED: The nominations for Mayor be closed.
Councilperson Johnson supported. Motion passed.

Ballot votes were cast to elect Councilperson Lehman as Mayor with five votes (Lehman, Linton, Barrus, Scoby, and Johnson), while two votes (Moss and Cunliffe) were cast for Cunliffe.

Meeting turned over to Mayor Lehman.

3. The second order of business was the election of Mayor Pro-Tem for the ensuing year.

Councilperson Cunliffe MOVED: Councilperson Moss be nominated for Mayor Pro-Tem.

Mayor Lehman MOVED: Councilperson Scoby be nominated for Mayor Pro-Tem.

Councilperson Johnson MOVED: The nominations for Mayor Pro-Tem be closed.
Councilperson Scoby supported. Motion passed.

Ballot votes were cast to elect Councilperson Scoby as Mayor Pro-Tem with four votes (Lehman, Linton, Barrus, and Scoby), while three votes (Moss, Johnson and Cunliffe) were cast for Moss.

4. Council considered setting the meeting schedule for the year.

Councilperson Moss MOVED: To establish City Council meetings for 2022 on the first and third Tuesday of each month at 7:30 pm and cancel the regular meeting on July 5th for the holiday week as presented. Councilperson Johnson supported. Unanimously adopted.

5. Council considered the appointment of City Council representatives to Committees, Commissions, and Boards.

Councilperson Cunliffe MOVED: To appoint members of City Council on City Boards, Commissions and Committees as follow:
