**ORDINANCE NO. 22-09**

**AN ORDINANCE TO AMEND THE OFFICIAL ZONING MAP TO  
REZONE VARIOUS PROPERTIES AS SPECIFIED HEREIN OF  
CHAPTER 46, "ZONING" OF THE CODE OF ORDINANCES OF THE  
CITY OF GREENVILLE.**

**THE CITY OF GREENVILLE ORDAINS:**

**Section 1. Amendment of Official Zoning Map.** The Official Zoning Map of the City of Greenville is amended such that the parcels in the list below are rezoned as indicated below and on the attached exhibit A:

421 N Lafayette St	052-705-001-50	Rezone to NLZD
