NOTICE OF PUBLIC HEARING GREENVILLE CITY COUNCIL

A public hearing will be held by the Greenville City Council on Tuesday, July 16, 2024 at 7:00 p.m., in the Council Chambers located in the Municipal Complex at 415 S. Lafayette Street, Greenville, Michigan, to consider adoption of a resolution to create an Industrial Development District, pursuant to Michigan Public Act 198 of 1974, as amended, as requested by Streamline Machine Source, Inc., regarding the real and personal property located within the City of Greenville and legally described as follows:
