A meeting of the Greenville Planning Commission will be held Thursday, November 11, 2021, at 6:30 pm. The purpose of the meeting is to hold the Planning Commission’s regularly scheduled meeting and the following public hearings:

1. An amendment to revise the requirements for the use of a nonconforming lot.
2. An amendment to allow a nonconforming building in a residential zone used for residential purposes to be rebuilt in the same location if damaged or destroyed.
3. An amendment to add regulations for major and minor amendments to an approved special land use.
4. An amendment to change the number of members of the zoning board of appeals from seven to five, to require that one member be a member of the planning commission and to provide for three-year staggered terms.

To mitigate the spread of the COVID-19 pandemic, protect the public health, and provide essential protections to City of Greenville residents; the City of Greenville boards and commissions are providing an option for members of the public and others to attend public meetings by video teleconference in addition to the physical public access at the usual meeting location. It is the intention of the City to be in compliance with any applicable State or County orders or regulations and also the Open Meetings Act in order to promote government accountability and foster openness in government to enhance responsible decision-making.

The **Greenville Planning Commission meeting** will be held via “Zoom” online meeting platform. The meeting is open remotely to the public to follow along and participate during the public portion of the meeting.
