6:30 P.M. ON THURSDAY, DECEMBER 9, 2021**

A meeting of the Greenville Planning Commission will be held Thursday, December 9, 2021, at 6:30 pm. The purpose of the meeting is to hold the Planning Commission’s regularly scheduled meeting and the following public hearings:

- a. To receive comments on amendments to the Greenville Zoning Ordinance to permit medical marijuana facilities and establishments, add certain definitions and other regulations related to the use of medical and adult use of marihuana and delete regulations prohibiting marihuana establishments and dispensaries.
- b. To receive comments on an amendment to the Greenville Zoning Ordinance to rezone properties from the C-2, General Commercial Zoning District, to a new district to be called the North Lafayette Zoning District. The parcels to be rezoned have frontage on Lafayette Street between the Flat River and Greenville West Drive.
- c. To receive comments on an amendment to the Greenville Zoning Ordinance to rezone properties from the IND, Industrial Zoning District, to a new district to be called the Industrial Park Zoning District. The parcels to be rezoned are located abutting and to the east and west of Industrial Park Drive and Fitzner north and south of VanDeinse.

To mitigate the spread of the COVID-19 pandemic, protect the public health, and provide essential protections to City of Greenville residents; the City of Greenville boards and commissions are providing an option for members of the public and others to attend public meetings by video teleconference in addition to the physical public access at the usual meeting location. It is the intention of the City to be in compliance with any applicable State or County orders or regulations and also the Open Meetings Act in order to promote government accountability and foster openness in government to enhance responsible decision-making.

The **Greenville Planning Commission meeting** will be held via “Zoom” online meeting platform. The meeting is open remotely to the public to follow along and participate during the public portion of the meeting.
