- **HAVE YOU INCURRED ADDED HOUSEHOLD EXPENSES DUE TO LOSS OF CHILD CARE RELATED TO COVID DURING THE TIME FRAME OF MARCH 2020 TO THE PRESENT?**
- **HAVE THERE BEEN FUNERAL EXPENSES DUE TO A COVID-RELATED DEATH IN YOUR HOUSEHOLD?**
- **ARE YOU POTENTIALLY FACING AN EVICTION, FORECLOSURE OR UTILITY SHUT-OFF RELATED TO LOSS OF WAGES OR OTHER FACTORS DIRECTLY RESULTING FROM COVID?**
- **WAS YOUR HOUSHOLD FINANCIALLY IMPACTED IN ANY ADDITIONAL WAY BECAUSE OF THE COVID-19 PANDEMIC DURING THE TIME FRAME OF MARCH 2020 TO THE PRESENT?**

THE TOWN OF GROTON MAY BE ABLE TO ASSIST WITH SPECIFIC OUTSTANDING HOUSEHOLD BILLS THAT ACCRUED FROM MARCH 2020 TO THE PRESENT AS A DIRECT RESULT OF THE COVID-19 PANDEMIC.

DOCUMENTATION WILL BE REQUIRED.

THE TOWN OF GROTON HAS AMERICAN RESCUE PLAN ACT FUNDING ALLOCATED TO HELP ELIGIBLE GROTON HOUSEHOLDS NEEDING BASIC HUMAN NEEDS ASSISTANCE IN CATEGORIES INCLUDING BUT NOT LIMITED TO HOUSING, UTILITIES, HOME HEATING FUEL, FOOD, CLOTHING, TRANSPORTATION, MEDICAL AND MENTAL HEALTH SERVICES, SUBSTANCE ABUSE SERVICES, CHILD CARE, FUNERAL/BURIAL COSTS AND OTHER NEEDS WHICH MAY BE IDENTIFIED THAT DIRECTLY RESULT FROM THE COVID –19 PANDEMIC.

THE TOWN’S GOAL IS TO HELP LOCAL FAMILIES RESTORE THEIR ECONOMIC AND EMOTIONAL STABILITY FOLLOWING UPHEAVAL CAUSED BY THE COVID-19 PANDEMIC.
