| 1/27/2021 | Unhappy with service provided | Unfounded | Ofcs responded to report of person who had fallen on the sidewalk. Ofcs determined the person was actually resting and they declined our assistance. No violation of policy or procedure |
| 2/11/2021 | Claims due process violated during arrest | Exonerated | Assist to another agency who were investigating a violent domestic assault involving a firearm. That agency made on sight arrest with our officers present. No violation of policy/procedure. |
| 6/13/2021 | Claims that officers pointed guns at him when they arrested him | Unfounded | Suspect in domestic violence case who was secreted in closet yelling that he was armed with a knife. Ofcs had guns drawn when affecting arrest but did <u>not</u> point weapons at him ; however, they would have been justified if they had. |
| 7/28/2021 | Claims Ofc unfairly went to home to question daughter | Unfounded | Ofc followed lead on burglary, was able to clear the daughter of any involment and advance the case. |
| 8/10/2021 | Citizen compl that Ofc made hand gesture at him while driving by | Not sustained | Ofc waved to citizen and gesture apparently misconstrued |
| 9/13/2021 | Questions Ofc did not properly charge in this case, didn't seize contraband or return her message | Unfounded Exonerated Sustained | Claim re improper charge: unfounded Claim re contraband: exonerated Claim re returning call: sustained |
| 9/27/2021 | Complainant was referred to hospital on a psych. evaluation and took exception to this | Exonerated | Referral was proper and according to law and policy |
| 10/26/2021 | Complainant claims girlfriend propositioned during MV stop | Unfounded | BWC footage completely refutes the claims without question. |
| 11/4/2021 | Took exception to report language used in psych. evaluation referral | Exonerated | Referral was proper and according to law and policy |
