
#### CONSENT AGENDA

Interim County Manager, Mr. David B. Cotton, shared with the Board that all revenues identified and the County remains stable at .84¢ tax rate per \$100 of evaluation, \$1.25 Million in outstanding taxes still due and that procedures are in place for the collection of delinquent taxes.

# REQUEST CONSIDERATION OF FOOD BANK OF THE ALBEMARLE FUNDING REQUEST

Interim County Manager David B. Cotton presented the \$15,000 funding request from the Food Bank of the Albemarle. He shared the following with the Board: 1) Ms. Liz Reasoner, Food Bank of the Albemarle Executive Director, requested an appropriation of \$15,000 to defray the cost of expanding the cooler/freezer storage and 2) he recommends the Food Bank seek funding from State resources.

#### INTERIM COUNTY MANAGER'S COMMENTS
