Part of that expansion included securing a Health Resources and Services Administration (HRSA) Facilities Improvement Grant of \$6.2 million and additional partner funding to build 43,000 sq. ft. facility in Ahoskie expanding from 27 exam rooms to 48, aided in the establishment of the ECU School of Family Medicine Rural Residency Program bringing medical students to practice in Hertford County and other rural areas of the State; and

WHEREAS, her expertise and leadership has been invaluable to Hertford County and its citizens; and

WHEREAS, the Roanoke Chowan Community Health Center and the citizens of Hertford County have benefited from her considerable talents and dedication to serving others; and

INTERIM COUNTY MANAGER'S REPORT: HEALTH DEPARTMENT PROJECT, COMPLETING ACCESS TO BROADBAND, CHERRY COMMUNITY CENTER, IT DEPARTMENT

Mr. Patterson provided updates as follows: Health Department Project initial estimates from Oakley Collier, renovation estimate for one of the wings at Ahoskie Elementary School,

Completing Access to Broadband working with Roanoke Connect Holdings to complete the three-party contract for the CAB Grant and the County required local contribution, a budget amendment will be added to the consent Agenda for the February meeting, Cherry Community Center payment for the nutrition site at the Amanda S. Cherry Community Resources Center, and the County agreement with SoundSide Group, Inc. is for three years (July 1, 2023 – June 30, 2026) with a six month termination feature for either party, a noncompete clause in their employment contracts, the IT Director position is budgeted, hiring two technicians with a combined salary of \$95,000.00 and fringe of 24%, \$22,800 and training and travel costs.
