REQUEST APPROVAL OF THE HERTFORD COUNTY BOARD OF COMMISSIONERS' RESOLUTION OPPOSING REDUCTION OF COUNTY AUTHORITY TO ADOPT POLICIES THAT BEST REPRESENT NEEDS OF COUNTY COMMUNITIES

On a motion by Com. Mitchell and a second by Com. Douglas, the Board approved the Hertford County Board of Commissioners' Resolution Opposing Reduction of County Authority to Adopt Policies that Best Represent Needs of County Communities as presented by Manager Cotton.



#### RESOLUTION OF THE HERTFORD COUNTY BOARD OF COMMISSIONERS OPPOSING REDUCTION OF COUNTY AUTHORITY TO ADOPT POLICIES THAT BEST REPRESENT NEEDS OF COUNTY COMMUNITIES

WHEREAS, the North Carolina General Assembly's proposed 2021 Appropriations Act includes law that if enacted will reduce county authority to adopt policies that best represent the needs of communities within counties and reflect values of a county's citizens as expressed through a county's land use plan, land use regulations and actions of the duly elected county governing boards; and

WHEREAS, the proposed reduction in local control and authority includes removing local authority to determine the location of relocated billboards; limiting local authority to establish storm water regulations essential for the maintenance of water quality and flood prevention; preemption of local authority on the placement of schools and prevention of local government adoption of ordinances related to the removal of trees; and

WHEREAS, the limitation or removal of local control over the cited matters would, in Hertford County, require ending local practices long accepted, expected and in some instances demanded over time by its citizens; and

WHEREAS, of particular concern is prohibiting a county's regulation of storm water more restrictively than provided in state or federal regulations will require Hertford County to repeal its existing storm water regulation that will then decrease by one-half the amount of storm water that development must contain on its property, allow faster release of storm water downstream, further exacerbate flooding and end the county's plan to further reduce storm water

impact on property outside of development by requiring upstream and downstream analysis of storm water facilities and outfalls; and

WHEREAS, requiring a county to ignore storm water infrastructure policy and needs specific to its topography will frustrate resiliency efforts that to date are endorsed and encouraged by the state government that now seeks to impede those efforts and result in further inundation of homes and property with flood waters and interference with private property rights.

**NOW, THEREFORE, BE IT RESOLVED** by the Hertford County Board of Commissioners that:

Section 1. Hertford County is opposed to language in the 2021Appropriations Act further reducing local control and requests that the North Carolina General Assembly, and in particular the county's legislative delegation Senator Bob Steinberg and Representative Howard J. Hunter, III, oppose any language in the final 2021 Appropriations Act that further reduces local authority and control over the public's health, safety and welfare.

Section 2. The Clerk to the Board of Commissioners is directed to forward a copy of this resolution to the Honorable Tim Moore, Speaker of the House of Representatives, the Honorable Phil Berger, President Pro Tempore of the Senate, Senator Bob Steinberg and Representative Howard J. Hunter, III.

## REQUEST APPROVAL OF RESOLUTION ESTABLISHING A HOME PROGRAM HOUSING CONSORTIUM

On a motion by Com. Douglas and a second by Com. Mitchell, the Board approved the Resolution Establishing a Home Program Housing Consortium as presented by Manager Cotton.

#### RESOLUTION

#### Establishing a HOME Program Housing Consortium

WHEREAS, the County of Hertford has determined that the health and welfare of the citizens within the jurisdiction may benefit from increasing the availability of safe, affordable and standard housing; and

WHEREAS, the County of Hertford has determined that providing safe, affordable and standard housing will benefit workforce productivity and area economic development; and

WHEREAS, a Consortium of local governments will be entitled to receive funds from the United States Department of Housing and Urban Development, which the local governments would be ineligible to receive individually; and

WHEREAS, the Cranston-Gonzalez National Affordable Housing Act of 1990, as amended, makes provisions whereby units of general government may enter into cooperative agreements and form Consortiums to undertake affordable housing pursuant to the HOME Investment Partnership Program; and

WHEREAS, the County of Hertford, along with the County of Bertie, County of Halifax, County of Martin, County of Northampton and the municipalities contained therein (Consortium membership), desires to establish the Choanoke Area Housing Consortium to undertake affordable housing initiatives under the Cranston-Gonzalez National Affordable Housing Act of 1990; and

WHEREAS, Article 20, Chapter 160A of the North Carolina General Statutes authorizes units of local government to enter into interlocal agreements with each other in order to execute an undertaking such as the contemplated Choanoke Area Housing Consortium;

NOW, THEREFORE BE IT RESOLVED, by the County of Hertford Board of Commissioners that:

- The County of Hertford hereby supports the establishment of the Choanoke Area Housing Consortium.
- II. The County Manager is hereby authorized to pursue a Cooperation Agreement with the Consortium membership and present the proposed agreement to the Board of Commissioners for ratification.

BE IT FURTHER RESOLVED, that this resolution shall be in full force and effect from and after its adoption this the 4th day of October 2021.

### RESOLUTION OF THE HERTFORD COUNTY BOARD OF COMMISSIONERS EXPRESSING CONCERN WITH UNFUNDED AND UNDERFUNDED STATE MANDATES FOR PUBLIC EDUCATION

WHEREAS, Article IX, §2 of the North Carolina Constitution provides "[T]he General Assembly shall provide by taxation and otherwise for a general and uniform system of free public schools, which shall be maintained at least nine months in every year, and wherein equal opportunities shall be provided for all students."; and

WHEREAS, the Court of Appeals of North Carolina, citing the North Carolina Supreme Court decisions in *Leandro v. State*, 346 N.C. 336, 488 S.E.2d 249 (1997) and *Hoke Cty. Bd. of Educ. v. State*, 358 N.C. 605, 599 S.E.2d 365 (2004), explained in *Silver v. Halifax Cty. Bd. of Comm'rs*, 255 N.C. App. 559, 805 S.E.2d 320 (2017) that "[T]he constitutional duty to provide a sound basic education rests upon the State."; and

WHEREAS, there has been a long tradition and partnership and cost sharing between the State and counties to fund public education operations and facilities; and

WHEREAS, it is becoming a State practice, no matter how well meaning, to reduce State spending by shifting to counties unfunded or underfunded mandates for the improvement of public education as exemplified by requiring that local school systems reduce the size of K-3 elementary school classes; and

WHEREAS, because of these unfunded or underfunded mandates, Hertford County is faced with expending millions of local taxpayer dollars for capital improvements and additional funding for teachers and other school operational costs; and

WHEREAS, Hertford County opposes state unfunded mandates and requiring county funding of State responsibilities without revenue to cover a county's cost of such funding.

NOW, THEREFORE, BE IT RESOLVED by the Hertford County Board of Commissioners that the North Carolina General Assembly, and in particular the County's legislative delegation, take no action that places additional financial burden on counties and that the State of North Carolina assume the unfunded and underfunded mandates placed upon counties.

SECTION IX: PRIVACY OR SECURITY EVENT LIABILITY OR EXPENSE COVERAGE

It is understood and agreed that coverage shall not apply under any of the above referenced forms as follows:

- arising out of or in any way related to the Intergovernmental Services Agreement (IGSA)
  entered into between Hertford County (Hertford), U.S. Immigration and Customs
  Enforcement (ICE) and/or The GEO Group, Inc. (GEO) and or any further agreements which
  are or might be entered into as between Hertford, ICE and/or GEO.
- to Hertford, it's officials, employees, elected sheriff and/or deputies with regard to any claim
  or suit arising out of or in any way related to the existing detention facility located at 145
  Parkers' Fishery Road, Winton, North Carolina 27986.
- to ICE and/or GEO.

It is expressly understood and Hertford hereby agrees that GEO has agreed to assume liability and be entirely responsible for any liabilities relating to the IGSA and/or Hertford's, ICE's and GEO's operation of the detention facility located at 145 Parker's Fishery Road, Winton, North Carolina 27986, by Hertford and that GEO has procured a policy of insurance as set forth in the IGSA which names Hertford as an additional insured of insurance.

While the IGSA provides for GEO to procure insurance coverage for Hertford, nothing in this exclusion is meant to be conditioned on the procurement of said coverage. Rather, Hertford specifically acknowledges and agrees that no coverage will be afforded to it, GEO, and/or ICE for any claim or suit arising out of or in any way related to the IGSA and/or the operation of a detention facility at 145 Parker's Fishery Road, Winton, North Carolina 27986.
