Hertford County Solid Waste Management Plan

DEFINITIONS

Current Program is the program established as the Solid Waste Management Plan.

Intended Actions are the changes to the programs for the first 10-year planning period.

1.0 SOURCE REDUCTION

Current Program: On January 1, 2011, Hertford County implemented the beginning stages of reducing cardboard from the waste stream. They began collecting cardboard and sending it to Butler Recycling in Suffolk, VA. In turn, the County is compensated for the recycled cardboard.

Intended Actions: There are no further actions intended.

2.0 COLLECTION

Current Program: Waste is collected and hauled by the County, Towns, and several private firms (see Table 11). The county also collects waste from seven collection ("convenience") centers located in the rural areas of the county (see map in Appendix D). The collection sites are manned by County personnel, and they are open to the rural residents for disposal of solid waste and the collection of recyclables (See Section C), Monday through Saturday, 9:00 am to 6:00 pm; except for Site 1 which operates Tuesday through Friday, 9:00 am to 6:00 pm and Monday and Saturday 9:00 am to 2:00 pm and Site 6 that is closed on Mondays. The County hauls the waste from the collection sites directly to the regional landfill. The furniture boxes at those sites may be taken to the transfer station instead of a direct haul to the landfill.

Winton, Cofield, and Harrellsville collect their own residential and non-residential wastes. Como utilizes the County convenience centers, except citizens that contract with private haulers. Ahoskie and Murfreesboro do not participate in the County's Solid Waste Management Plan.

Fiscal Year (FY) 09-10 collected 471 tons less waste than FY 08-09. It has been attributed to a slower economy and a more effective recycling program.

Intended Actions: There are no further actions intended for the planning period.

3.0 RECYCLING AND REUSE

Recycling

Current Program: Hertford County has been working since 1989 to maintain a stable recycling program. Currently, the county is recycling about 2.65% of the residential waste in the planning area. Seven collection centers have a variety of collection bins, including roll-offs and converted dumpsters. Materials collected include: cardboard, newspaper, pesticide containers, aluminum cans, steel cans, clear and colored glass, #1 and #2 plastics, wooden pallets, and white office paper. Special waste, including used oil and oil filters, is also collected at these sites. Collection center staff is available to answer questions and teach residents proper sorting and material preparation. Approximately one-third of the residents who use the convenience centers recycle. Brochures containing recyclable material listings, phone numbers, and other information are available at each site.

Each municipality has a curbside recycling program that picks up newspaper, aluminum and steel cans and plastics. Como uses the convenience center for their recyclables. The County and municipalities combine their recyclables. Glass is transported to Reflective Recycling in Wilson, NC. Recycled plastics and cardboard are taken to Butler Recycling in Franklin and Suffolk, Virginia. The total amount of recyclables is about 156 tons.

It is assumed that residents who currently use the solid waste and recycling collection centers will continue to recycle. Collection center staff has been monitoring recycling habits and have seen a steady increase in the number of people who recycle. Approximately half of the residents currently using the collection centers use the recycling bins. Collection center staff continually educates residents on how to separate materials.

Based on the Waste Reduction Goals Calculation, non-residential recycling is targeted to reduce waste by 480 tons. Research into potential new recycling markets may prove to be a key to reducing non-residential waste.

Antifreeze is collected at Sites #2, #4, and #7.

Intended Actions: There are no further actions planned.

Reuse

Current Program: Any reusable items that are dropped off at the convenience centers or transfer station is set aside for use by anyone wishing to utilize them.

Intended Actions: There are no further actions planned.

Electronics

Current Program: Effective October 1, 2010 Herford County implemented an electronic waste recycling program that will benefit multiple municipalities and local businesses. Materials to be recycled include but are not limited to; CRTs, TVs, hard drives, scanners, fax machines, copiers, and other miscellaneous electronic equipment. Hertford County will work with an electronics recycling company that has received certifications in compliance with the requirements of the State of North Carolina.

Hertford County has established seven collection sites around the county for residential drop off. These sites will be located at 606 Benthall Bridge Road, Murfreesboro; 110 Drive In Theatre Road, Ahoskie; 123 Newsome Grove Road, Ahoskie; 227 Mt Moriah Road, Winton; 317 Statesville Road, Como; 436 St. Johns Millennium Road, Aulander; and 2344 NC 45 S, Harrellsville. The material will be placed in RoParks for pick up by eCycleSecure, LLC, 1500 N Graham, NC 28203 (telephone: 704-376-1116, fax: 704-376-1112). eCycleSecure will pick up the material as needed by the county and transport it to their facility for recycling and further disposal.

After electronic waste collection, eCycleSecure will send Hertford County a statement that lists the tonnage of material disposed, broken down by computer equipment, televisions, and other electronic material. eCycleSecure will keep these statements on file, as a record of material collected and disposed by each unit of local government.

Public Awareness

Hertford County is incorporating several levels of public education, regarding the new electronics recycling program. Flyers will be posted at convenience sites to inform citizens of electronics waste collection locations. Signs will be posted at the landfill explaining the new landfill ban on CRTs and TVs as well as the new locations of collection sites. Articles in the local newspaper will inform citizens of the new law, its requirements, and the options established by Hertford County.

Funding will be a separate line item within the solid waste budget. The county can justify spending funds on electronics recycling because this growing waste stream will free up space in the landfills.

Additionally, removing the electronic waste eliminates a possible contamination hazards from toxic materials used in the electronics manufacturing processRemoving the electronic waste stream will free up space in the landfills as well as eliminating a possible contamination hazard from toxic materials used in the electronics manufacturing process.

Intended Actions: There are no further actions planned

4.0 COMPOSTING AND MULCHING

Current Program: There are no current programs in the planning area.

Intended Actions: There are no further actions planned.

5.0 INCINERATION WITH ENERGY RECOVERY

Current Program: Incineration with energy recovery is not part of the county's current program. The county considers it an inappropriate waste management option due to the local waste flow, public opinion, and capital/operating costs.

Intended Actions: The County does no plan to use incineration without energy recovery.

6.0 INCINERATION WITHOUT ENERGY RECOVERY

Current Program: Incineration is not part of the county's current program. The county considers it an inappropriate waste management option due to the local waste flow, public opinion, and capital/operating costs.

Intended Actions: The County does not plan to use incineration without energy recovery.

7.0 TRANSFER OUTSIDE THE GEOGRAPHIC AREA

Current Program: Hertford County and all of the municipalities transfer their waste out of the geographic boundaries of the County. Waste is taken to the transfer station where Hertford County sorts items for distribution to their respective parties. Metals are taken by Liverman metal Recycling, Kelford, NC. The solid waste collected is hauled to the Addington Landfill in Bertie County. The Towns of Winton, Cofield, and Harrellsville haul their waste to the transfer station where Hertford County transfers it to the Regional Landfill. The Town of Como utilizes convenience centers.

Intended Actions: There are no further actions intended for the duration of this planning period.

8.0 DISPOSAL OF SOLID WASTE

Current Program: Hertford County and all of the municipalities utilize the Addington Landfill in Bertie County to dispose of their residential, non-residential, and construction/demolition wastes.

Intended Actions: There are no further actions planned for this planning period. Hertford County's contract with the Addington Landfill expires in 2014.

9.0 EDUCATION OF COMMUNITY AND SCHOOLS

Community Education

Current Program: Hertford County, upon request, has and will present the Solid Waste Program to any Civic Clubs and Municipalities. This educational program represents multiple aspects including recycling, waste disposal, and special wastes such as; white goods, used motor oil and tires. The educational program also consists of the proper disposal of pesticide containers. Brochures and assistance concerning recycling are also available at the convenience centers. The municipalities utilize the County for their educational purposes.

Intended Actions: There are no further actions planned.

School Education

Current Program: Hertford County has and will present their solid waste program to any school upon request. The program emphasizes the importance of waste reduction and its future impact. The program also teaches students about proper waste disposal, including special wastes such as tires, white goods, and used motor oil.

Intended Actions: There are no further actions planned for this planning period.

10.0 MANAGEMENT OF SPECIAL WASTES

Tires

Current Program: Tires are collected at the transfer facility in trailers. The Towns of Winton, Cofield, and Harrellsville will haul tires that have been left at the curbside. Central Carolina Tire of Cameron, North Carolina, picks up the tires for \$1020.68 per load, of which approximately 100% is recycled. There were 17,617 tires collected in FY 09-10.

Intended Actions: There are no further actions planned.

White Goods

Current Program: White goods are accepted from Hertford County citizens at the transfer station where they are stored until pickup. Hertford County recycled about 69 tons of white good in FY 09-10. The freon is removed by Liverman's Metal Recycling and the white goods and other scrap metal is transported to their facility in Kelford, NC.

Intended Actions: There are no further actions planned.

Lead Acid Batteries

Current Program: There is no current program for the planning area.

Intended Actions: There are no actions planned for this planning period.

Used Motor Oil

Current Program: Citizens of Hertford County can drop off their used motor oil and oil filters at the convenience sites where FCC Environmental of Norfolk, Virginia will pick them up for recycling. There was 7,210 gallons of oil collected in FY 09-10.

Intended Actions: There are no further actions planned for the planning period.

Household Hazardous Waste

Current Program: There is no current program for the planning area.

Intended Actions: There are no actions planned for this planning period.

11.0 PREVENTION OF ILLEGAL DISPOSAL AND MANAGEMENT OF LITTER

Illegal Disposal

Current Program: the County Litter Control Officer who will also assist the municipalities upon their request enforces The County ordinances. The Litter Control Officer also investigates illegal dumping to see if the owner of the waste can be identified so that enforcement actions can be taken against the illegal disposal.

Intended Actions: No further actions are planned.

Litter Management and Promiscuous Dumping

Current Program: the County Litter Control Officer who will also assist the municipalities upon their request enforces The County ordinances.

12.0 PURCHASE OF RECYCLED MATERIALS AND PRODUCTS
