PURPOSE

The County of Hertford, North Carolina is seeking proposals from qualified architects/firms to provide complete architectural and engineering services for the design of a new Health Services and Senior Services building. The contract services will include complete design services: site investigation/assessment, schematic design, design development, construction documents, bidding, public representation, construction administration and supervision, state, local and all other code and permitting compliance, close out, project management consulting with specific expertise in quality assurance/value engineering, constructions feasibility review, cost loaded scheduling, cost estimating and scheduling.

PROJECT OVERVIEW

The project will be constructed on one of two sites owned by Hertford County. The primary location under consideration is the Hertford County Government Campus located at Justice Drive in Winton. The alternative site is located in the vicinity of Tryon Street and North King Street in Winton. The current Health Services Building located at 828 South Academy Street in Ahoskie is approximately 6,350 square feet containing offices, lobby, examination rooms, conference room and other support spaces. The existing Senior Services Building located at 408 South Camp Street in Winton is approximately 3,500 square feet containing offices, lobby, kitchen, dining room, exercise space, conference room and other support spaces. The anticipated combined use building will include: offices, conference/training room(s), interior storage space(s), lobby, commercial kitchen, dining room, laboratory, examination rooms and other support spaces. The selected architect/firm will analyze the existing Health Services Building, Senior Services Building and property to determine the highest return on investment based on the identified uses and needs. The total budget for the project including the total square footage has yet to be finalized and it will be driven by the results of the programming and design phase outcomes.

The selected architect/firm will work with a local civil engineering and surveying firm, which is contracted to complete design survey, topography contours, erosion control, stormwater best management practices design/permitting and grading plans.

OBJECTIVES

The County of Hertford, North Carolina proposes to retain a highly qualified and experienced architect/firm to provide complete design services as outlined in the first paragraph of the **PURPOSE** above, for a fixed cost. The selected architect/firm must have a commitment to designing a facility, which functionally meets the current and expected growth in the area while adhering to local architecture and history. Therefore, the selected architect/firm shall be familiar with local design requirements, themes and development processes. The County of Hertford is the owner, as such all financial and contract decisions will be made by the County.

SUBMITTAL REQUIREMENTS

- Name, email address, phone number and physical address of the designer/architect. In the event of a firm, the names of the officers, directors and owners along with the email addresses, phone numbers and physical address of the firm.
- Names and certificate numbers of those offices, directors and owners who are registered architects and professional engineers.
- Demonstrated architect/firm experience in facility design, adaptive reuse, renovations and remodeling, including experience in architectural and public space planning, design and construction management.
- Resumes of the project architect and key personnel who will be involved with this project: their qualifications and experience related to the scope of work detailed above as well as their anticipated assignments related to this project. Specific information on their background, training and experience with similar projects should be included.
- List of all public projects undertaken in the past five (5) years in North Carolina as well as current projects.
- List of at least five (5) client references for related projects with contact name, telephone number and email address.
- Document any history of litigation associated with project performance and/or professional liability and all matter settled out of court.
- Hourly rate of pay for personnel proposed for this project.
- Financial statement from certified public accountant stating he/she has examined the applicant's internal auditing controls.
- A statement in which the applicant certifies that the information provided is correct and accurate, under penalty of perjury.
- Submit five (5) copies of applicant's response to RFQ and a digital pdf copy.

EVALUATION CRITERIA

Applicants will be evaluated on their ability to demonstrate:

- Experience: Previous experience and qualifications of the firm as well as personnel as they relate to this project.
- Quality of Work: Previous projects will be viewed and/or customers interviewed to determine the quality of and commitment to work provided.
- Public Sector Knowledge: Previous experience and knowledge of current North Carolina public construction laws, bid specifications and bidding procedures.
- Sustainable Design: Previous experience and knowledge of sustainable and logistical design.
- Capacity: The ability of the applicant to undertake and complete the project in the timeframe established.
- Professional references.

SELECTION PROCESS

Hertford County staff will evaluate each submitted RFQ and may select Architect(s)/Firm(s) to interview. Upon selection, a recommendation will be made to the Hertford County Board of Commissioners for consideration and formal action.

The County of Hertford reserves the right to reject any and all proposals received as well as waive any irregularities, and to modify any stated timelines or deadlines.
