### Post Meeting Brief

At the April 15<sup>th</sup>, 2024 Board of Commissioners' meeting, routine agenda items and essential operational needs were addressed by the Board. The Board Meetings are held in-person, in the Multipurpose Room/Commissioners Chambers, located on the 2<sup>nd</sup> Floor of the Judicial Center (119 Justice Drive, Winton). ### Highlights from the April 15<sup>th</sup> 2024 Commissioners' Meeting:

- As part of the Consent Agenda, the Board approved the Meeting Minutes from April 1, 2024, and a Taxpayer Refund was also approved. Additionally, a Proclamation was unanimously approved Honoring the Memory of Nettie Celestine Combo Brickers. Under the same Agenda Item, Resolutions were unanimously approved for the following:
  - Income Maintenance Caseworkers Week (April 22-26, 2024)
  - Administrative Professionals Day (April 24, 2024)
  - Resolution In Support of Road Improvements Along Intersection of US13/SR1419 DT Road.
- The Board approved Budget Amendment #16 to the Fiscal Year 2023-2024 Budget Ordinance. This amendment includes the following changes:
  - Cybersecurity Remediation Initiative Grant for E911
  - Contribution for Hertford County Special Olympics Spring Games
  - WAVE Courthouse Project
  - OSBM Grant for Hertford County Public Safety Agencies
- Interim County Manager Patterson gave his report which included updates on the topics of the Old Election Building, Enterprise, Old Ahoskie Elementary School Project, Access Chowan, and the Roanoke Electric Membership Corporation Application to the Department of Energy Letter that has been requested.
- The Board Clerk provided an update of recent and upcoming meetings and events. She also acknowledged Hertford County E911 for National Public Safety Telecommunicator's Week, which is April 14-20, 2024. E911 Director Felicia Gaston and E911 Certified Training Officer, Inga Miner were present at the meeting.
