8. Presentation and appropriate action on proposed Eagle Scout Projects. (Shaylee

DeWitt and Stacey Baker, Community Development Specialist)

Stacey Baker, Community Development Specialist introduced Shaylee Dewitt and turned the presentation over to Shaylee who introduced herself and explained she was a scout with the Eagle Scout Troop # 715 out of League City, Texas and wanted to do a volunteer project in the City of Hitchcock and become an Eagle Scout. Shaylee presented her proposed project to council, and explained she'd been working with the fire department, fire marshal and public works department to determine the most needed locations throughout the city that she could place 250 blue reflectors on the roads to help first responders locate water lines and fire hydrants. Shaylee reported she would be putting a committee together to help her determine the cost of her project, she would accept, and will be looking for donations, anything would greatly be appreciated, the project would take approximately 6 months to complete.

Councilman Tuck made the motion to approve the proposal from Shaylee DeWitt for her Eagle Scout project. Seconded by Councilwoman Demby. Motion passed unanimously.

David Craig, project manager with Performance Services gave the City Council an update on the progress on replacing all water meters within the city, and reported they only have three large meters left to replace. The entire project should be completed by October 24, 2023.
