### 4. Citizen Comments:

<u>Patty McNeal</u>: 7032 Caldwell; address Council and told them she has lived in Hitchcock for over 75 years, that she is concerned about the citizens that live here, and the major issues at Missionary Village Apartments, these people are being taken advantage of, someone should be held accountable, and made to take responsibility for the residents that live there. With no hot water, gas and some days without electricity, something must be done, to make the owner be held accountable.

<u>Mike Joubert</u>: sent a letter to have read to the Council, Patty McNeal read the letter to the Council to express his concerns and dismay with the horrible living conditions at Missionary Village Apartments, "my niece lives there, so I have a vested interest in this situation. It seems to me the city does not care about the residents that live there, knowing the safety issues and violations at the apartments. "What is the City doing to correct these issues." These people cannot continue to live this way and in these conditions.

Discussion and appropriate action adopting an Ordinance of the City Council of the City of Hitchcock, Texas, setting the Ad Valorem Tax Rate of the City of Hitchcock, Texas for Tax Year 2023 at a rate of \$0.495000 per one hundred dollars (\$100) valuation on all taxable property within the corporate limits of the City of Hitchcock, Texas; specifying separate components of such rate for operations and maintenance and for debt services; providing for due and delinquent dates together with penalties and interest; providing for collection; and providing for an effective date. Marie Gelles, City Manager addressed the Council to recommend adopting and setting the FY 2023 Ad Valorem Tax Rate of \$0.495000 per one hundred (\$100) valuation. And called for a recorded vote.
