Leroy Thomas advised that the workers through this program will be treated the same as regular employees of the City and yes, the City would be able to dismiss them if necessary.

Wayne Newton made a motion to approve authorizing the City Manager to execute an agreement with Texas Workforce Solutions to participate in the On-the-Job Training Program. Mayr Combs Demby seconded the motion. Motion passed 5-0.

18. Discussion and appropriate action on an Ordinance of the City Council of the City of Hitchcock ratifying the property tax revenue increase reflected in the Fiscal Year 2022-2023 Budget that will require raising more revenue from property taxes than in the Fiscal Year 2021-2022 Budget by \$289,379 or 13.06% and of that amount \$144,010 is tax revenue to be raised from new property added to the roll this year. (Marie Gelles, City Manager)

Mayor Chris Armacost made a motion to adopt an Ordinance of the City Council of the City of Hitchcock ratifying the property tax revenue increase reflected in the Fiscal Year 2022-2023 Budget that will require raising more revenue from property taxes than in the Fiscal Year 2021-2022 Budget by \$289,379 or 13.06% and of that amount \$144,010 is tax revenue to be raised from new property added to the roll this year. Mary Combs Demby expressed her concern for raising the rates on the citizens of Hitchcock but that she understood why it was necessary.

Leroy Thomas explained the water and wastewater system is severely outdated and is in constant need of repair or replacement and that a rate increase is necessary to help with the costs of the constant work needed on the system.

Andre Perkins asked if these rates will be reviewed again in the next year.

Marie Gelles advised the rates will be reviewed again in a couple of years.

Wayne Newton made a motion to adopt an Ordinance establishing rates to be charged for water and wastewater services provided by the City of Hitchcock; Repealing Ordinance No. 2019-0030, dated September 30, 2019, and all other Ordinances or parts of Ordinances in conflict herewith; providing for severance; and providing an effective date of October 1, 2022. Shawn Kadlecek seconded the motion. Motion passed 5-0.

Mary Combs Demby and Andre Perkins suggested to add the Juneteenth Holiday without removing the Floating Holiday.

Wayne Newton asked what the cost to the City is by adding a Holiday. Item was tabled to review the cost associated with adding a Holiday top the City

calendar.
