THE APPLICANT FURTHER AGREES TO INDEMNIFY THE CITY FOR ANY EXPENSE OR LOSS IT MAY INCUR OR SUSTAIN AS A RESULT OF THE ABOVE DESCRIBED WORK, OR THROUGH INJURY TO ANY PERSON OR PROPERTY ARISING THEREFROM. NO PERSON SHALL OCCUPY ANY STREET WITH ANY MATERIALS OR MACHINERY INCIDENTAL TO THE CONSTRUCTION, DEMOLITION OR REPAIR OF ANY BUILDING ADJACENT TO SAID STREET, OR FOR ANY OTHER PURPOSE, WITHOUT FIRST OBTAINING A PERMIT AND FILING A BOND OF NOT LESS THAN THIRTY TWO HUNDRED (\$3,200) DOLLARS.

**RIGHT-OF-WAY:** For the purpose of this permit, "Right-of-Way" shall mean: The land lying between property lines on either side of a street, alley or boulevard in the City, including lawn extensions, sidewalks and the area reserved therefor where the same are not yet constructed.
