THE APPLICANT FURTHER AGREES TO RESTORE ALL PUBLIC PROPERTY TO A CONDITION AS GOOD AS THAT WHICH EXISTED BEFORE WORK BEGAN. THE APPLICANT FURTHER AGREES TO INDEMNIFY THE CITY FOR ANY EXPENSE OR LOSS IT MAY INCUR OR SUSTAIN AS A RESULT OF THE ABOVE DESCRIBED WORK, OR THROUGH INJURY TO ANY PERSON OR PROPERTY ARISING THEREFROM. NO PERSON SHALL OCCUPY ANY STREET WITH ANY MATERIALS OR MACHINERY INCIDENTAL TO THE CONSTRUCTION, DEMOLITION OR REPAIR OF ANY BUILDING ADJACENT TO SAID STREET, OR FOR ANY OTHER PURPOSE, WITHOUT FIRST OBTAINING A PERMIT AND FILING A BOND OF NOT LESS THAN THREE THOUSAND (\$3,000) DOLLARS.

Note: No system is to be installed until approved copy of this permit is returned to the Contractor. There is a \$40 penalty for failure to call for inspection within 90 days of completion of job.
