TUESDAY, NOVEMBER 8, 2022  
CITY OF HUNTINGTON WOODS**

**To the Qualified Electors of the City of Huntington Woods, County of Oakland:**

**PLEASE TAKE NOTICE** that any qualified elector of the City of Huntington Woods who is not already registered, may register to vote at the City of Huntington Woods Clerk’s Office; the office of the County Clerk; a Secretary of State branch office, or other designated state agency. Registration forms can be obtained at [mi.gov/vote](http://mi.gov/vote) or [www.hwmi.org](http://www.hwmi.org) and mailed to the City Clerk. Voters who are already registered may update their registration at [www.expressSOS.com](http://www.expressSOS.com).

The last day to register in any manner other than in-person with the local clerk is **Monday, October 24, 2022**

After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL168.492) at the City of Huntington Woods Clerk’s office, located at 26815 Scotia Rd., Huntington Woods, MI 48070 at the following times:

- Monday – Friday, 8:30am – 5:00pm (closed for lunch from 1:00-2:00pm except for the week prior to election)
- Saturday, November 5, 2022 from 8:00 a.m. to 4:00 p.m.
- **Election Day, Tuesday November 8, 2022 from 7:00 a.m. to 8:00 p.m.**

**AND FOR THE FOLLOWING PROPOSAL:**

- State Proposal 22-1  
A proposal to amend the state constitution to require annual public financial disclosure reports by legislators and other state officers and change state legislator term limit to 12 total years in legislature.
- State Proposal 22-2  
A proposal to amend the state constitution to add provisions regarding elections.
- State Proposal 22-3  
A proposal to amend the state constitution to establish new individual right to reproductive freedom, including right to make all decisions about pregnancy and abortion; to allow state to regulate abortion in some cases; and forbid prosecution of individuals exercising established right.
- County Proposal – Oakland County Public Transportation Millage – A proposal to authorize Oakland County to levy a milage for the purpose of funding public transportation services in Oakland County.
