a. Board Order No. 2025-042; In the Matter of Delegating Contract Signing Authority for Fair Entertainment Contracts to the Josephine County Recreation Director

Tamra Martin, Recreation Director, discussed that the Josephine County Fair is coming up within the next month and a half. Giving Ms. Martin signing authority allows her to focus and put her time into planning a successful fair for 2025.

b. Board Order No. 2025-039; In the Matter of Appointment of an Interim Public Health Administrator

Commissioner Blech discussed that Janet Fredrickson feels confident in being appointed as the Interim Public Health Administrator. This is a state requirement to have an individual fill that position.

Board Discussion and Action:

Commissioner Smith moved to approve the Consent Calendar Agenda Items 8(a) as listed, seconded by Commissioner Barnett. Upon roll call vote: Commissioner Smith – yes, Commissioner Barnett – yes, and Commissioner Blech – yes. Motion carried 3-0.

Commissioner Barnett spoke about having a meeting scheduled on June 10th with the Library.

Commissioner Blech discussed a public records request, where the District Attorney has made a ruling. Discussion held on the order from the DA. Commissioner Barnett made a motion after reviewing and weighing the required considerations in the order from the District Attorney to reduce this public records request fee by 10%. Seconded by Commissioner Blech. Upon roll call, Commissioner Smith – yes, Commissioner Barnett – yes, Commissioner Blech – yes. Motion carried 3-0.

10. MATTERS FROM COMMISSIONERS:

Commissioner Barnett read a letter he received from a constituent, in support of the Sheriff's Office. He congratulated all the high school graduates, and spoke about concerts in the park starting soon.
