Welcome/Introduction/Pledge of Allegiance

Rudy Carter, Chairman of the CTC, welcomed everyone to the meeting and stated that there are six members present and there is a quorum. The Pledge of Allegiance to the American Flag was said.

Invocation

Committee member Bob Bundy led the invocation.

Approval of Agenda

Earl Capps moved to approve the agenda as written. Seconded by Ronald Burke. Passed 6-0.

Approval of the Minutes

Earl Capps made the motion to approve the Minutes of the April 26, 2018 meeting. Seconded by Jack Patterson. Passed 6-0.

Citizens Comments

Rick Crimminger: Spoke regarding Bethel Boat Landing Road in the Edgewater Community.

David Reichard: Spoke regarding Bethel Boat Landing Road in the Edgewater Community and would like the Committee to consider the road for pavement as the Edgewater community grows.

Joseph DeGang: Spoke regarding Possum Hollow Road.

Greg Summers: Spoke regarding Carousel Lane and Apollo Lane.

Shelia Perry: Spoke regarding Hancock Road and would like it widened, paved and striped.

Steve Willis: Gave an update on a few things.

Report on SCDOT projects- SCDOT

Jeff Catoe, Public Services Director gave a few SCDOT updates.

Report on CTC/CSP projects-Jeff Catoe, Lancaster County Public Services

Jeff Catoe, Public Services Director stated that all of CSP projects are completed.

Discussion / Action Items

1) Trail funding

Sherri Gregory, stated that she wanted to speak with the Committee members about a TAP grant opportunity. The pedestrian access to the trail is not very good. There has been discussion about a project possibly doing some projects on Woodland Drive. The potential sidewalk project would run along the north side of woodland drive adjacent to the park and would also include a safe bus practices well designed pedestrian bicycle crossing across Main Street. The trail has been approved by DHEC to go under Main Street as well but there really needs to be a crossing over main street crossing to allow people get over and off the trail onto White Street. The grant opportunities are \$400,000 apiece. Discussion was had about submitting three of those and those require a \$100,000 match.

2) FY 2018/2019 Budget Discussion

Jeff Catoe, Public Services Director reviews the 2018/2019 budget with the Committee.

3) L&C Railroad Crossing Update

Jeff Catoe, Public Services Director, stated that they carried forward CTC's pledge to not exceed \$150,000 into the next fiscal year. L&C has ran into some poles that Duke Power needs to move. There is no construction date on the construction yet.

4) Airdale Road/ Timberlake Estates

The trees are cleared out and it is a lot safer now but they will be continuing their study with the cost estimate and get a design and then bring it back to the Committee. It would more than likely be two separate sub divisions.

5) Gravel Roads Discussion

Jeff Catoe, Public Works Director gave a brief overview of the gravel roads within the County.

6) Witherspoon Trail update

The school district will bid that round and the County will have to inspect it but the School district does plan to relocate that first 300-400 feet of Witherspoon Trail off of 521.

7) Hector Road / Hancock Road

Jeff Catoe, Public Services Director stated that the Development agreement does call for the first developer to resurface Hancock Road. When L Star took over they sat down and discussed the development agreement and L Star is prepared for a payment in lieu of around \$244,000 to contribute, but it has to be contributed to Hector and Hancock Road or Walnut Creek. A study was prepared for both of the roads and a cost estimate in the range around 600,000. When the design I completed then that is the time that it will come back to the CTC Committee.

8) Regent Parkway discussion

Jeff Catoe, Public Services Director stated that it is still a private maintained road the road belongs to the developer. If the developer deeds over the road to the County and the County bring the road up to meet DOT standards then the DOT will accept the road into the system but that is not definite.

9) Providence Road / Ten Oaks Road Contract Approval

Earl Capps made the motion to approve the contract. Seconded by Leonard Sims. Passed 6-0.
