Members Present: Jack Patterson, Rudy Carter, Earl Capps and Al Palmer arrived to the meeting at 6:18 p.m. Ronald Burke and Leonard Sims were absent.

Welcome/Introduction/Pledge of Allegiance

Rudy Carter, Chairman of the CTC, welcomed everyone to the meeting and stated that quorum was not met so they would conduct the business that they could without a vote. Jack Patterson led the Pledge of Allegiance to the American Flag.

Invocation

Jack Patterson led the invocation.

Approval of Agenda

Earl Capps moved to approve the agenda as written. Seconded by Jack Patterson. Passed 3-0.

Approval of the Minutes

Earl Capps moved to approve the Minutes of the November 30, 2016. Seconded by Jack Patterson. Passed 3-0.

Citizens Comments

Steve Gedney, 512 S. Main Street Lancaster, SC. Spoke regarding L&C Railroad.

Steve Willis, P.O. Box 1809 Lancaster, SC 29721. Spoke regarding potential future items.

Al Palmer arrived to the meeting. Chairman Rudy Carter stated that there is now a quorum and items can be voted on at this point.

Discussion / Action Items

1) SCDOT project update- John McCarter/Ken Wilson

- Jeff Catoe stated that Mr. McCarter couldn't make the meeting so he was going to try and cover what he could. One of the things that they get lots of calls about is the Lancaster side of 160. The project was awarded to Blythe Development. Mr. Catoe stated the Mr. McCarter mentioned to him that they are still doing some utility relocation and dealing with three properties with some right of ways. Work start up may be fall 2017 and a completion date near fall 2018.

2) Review of Lancaster County CTC / Capital Sales contract work – Jeff Catoe

- There are six roads that will be completed summer of 2017. By the time fall gets here all of those projects should be completed.

3) County gravel road discussion (Witherspoon Trail) – Jeff Catoe

- The new school that is located on 521 school's plan is now to utilize that road and they will probably have the bus access. That is one of the two roads that run into North Carolina. Jeff Catoe stated that this may be a good time to partner with the school district.

4) Sardis Road guard rail/safety improvements – Jeff Catoe

- Discussion of Schedule A was spoken about and they went through the packet and spoke about each picture. Schedule A is attached. A motion was made by Earl Capps to go on with the project. Seconded by Al Palmer. Passed 4-0.

5) Candidates for SCDOT 25% resurfacing (Collins Road, Charles Pettus Road, Plyler Mill Road) and County maintained spurs (Stormy Lane, Saddle Road) – Jeff Catoe

- Discussion about the candidate for SCDOT 25% resurfacing. Jeff Catoe discusses each road and the concerns that each one had.

Earl Capps made the motion to go forward with the project. Seconded by Jack Patterson. Passed 4-0.

Chairman adjourned and Earl Capps seconded. Passed 4-0.

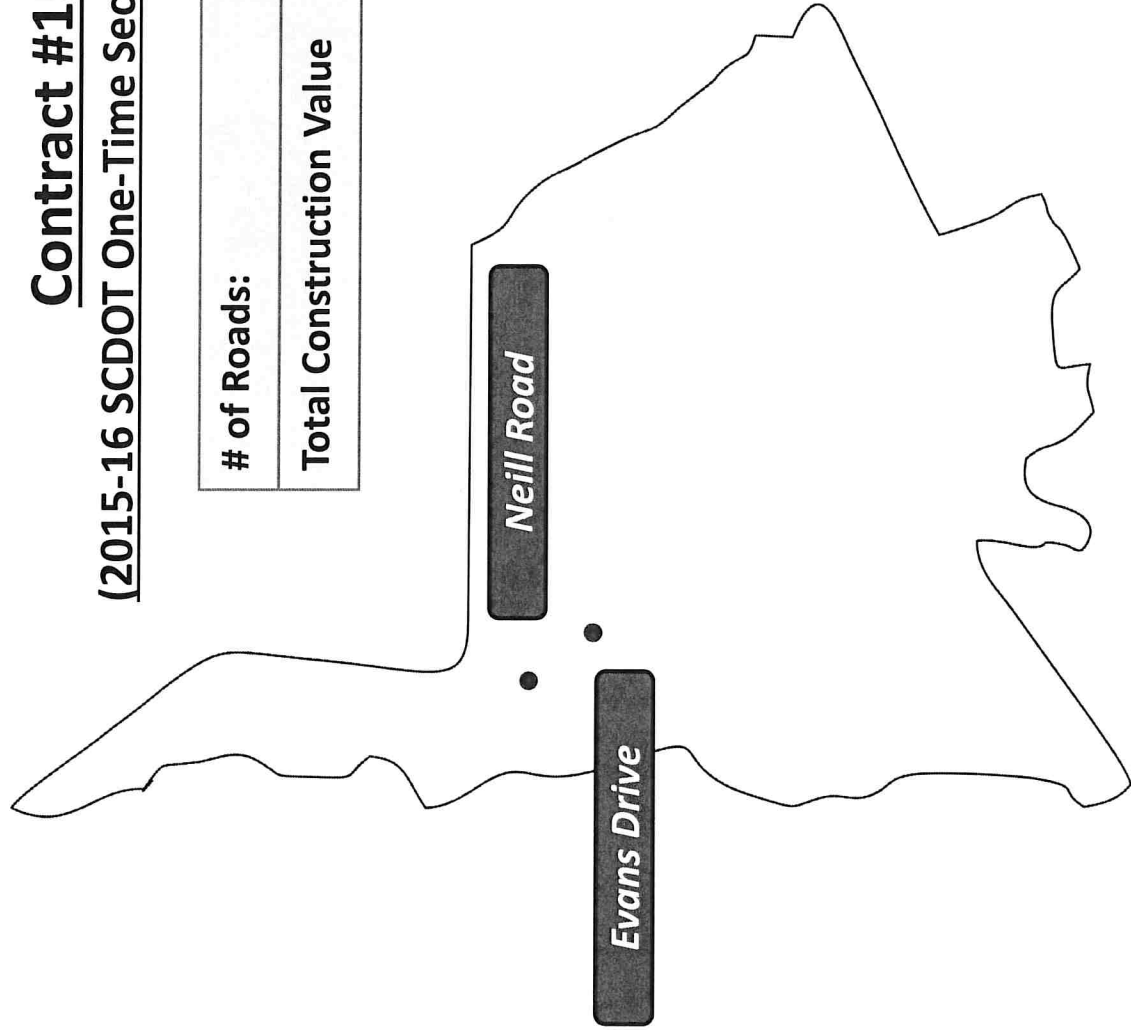

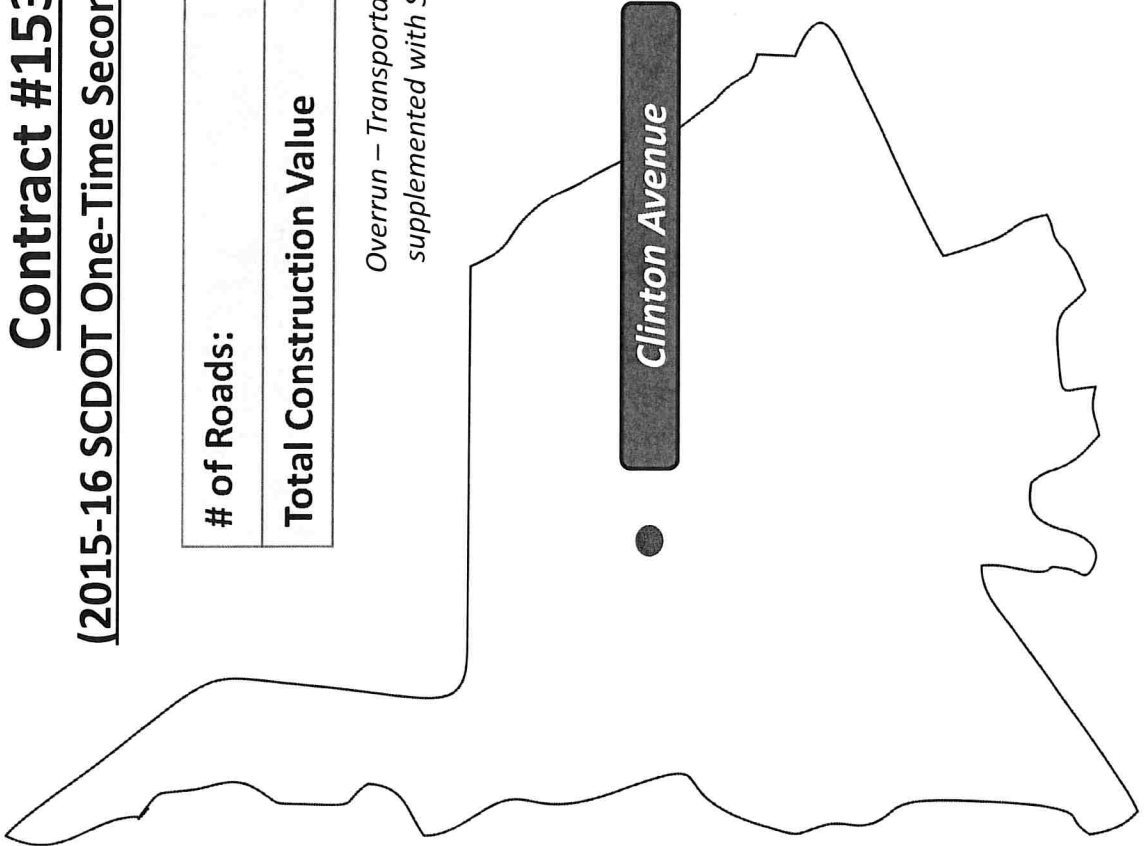

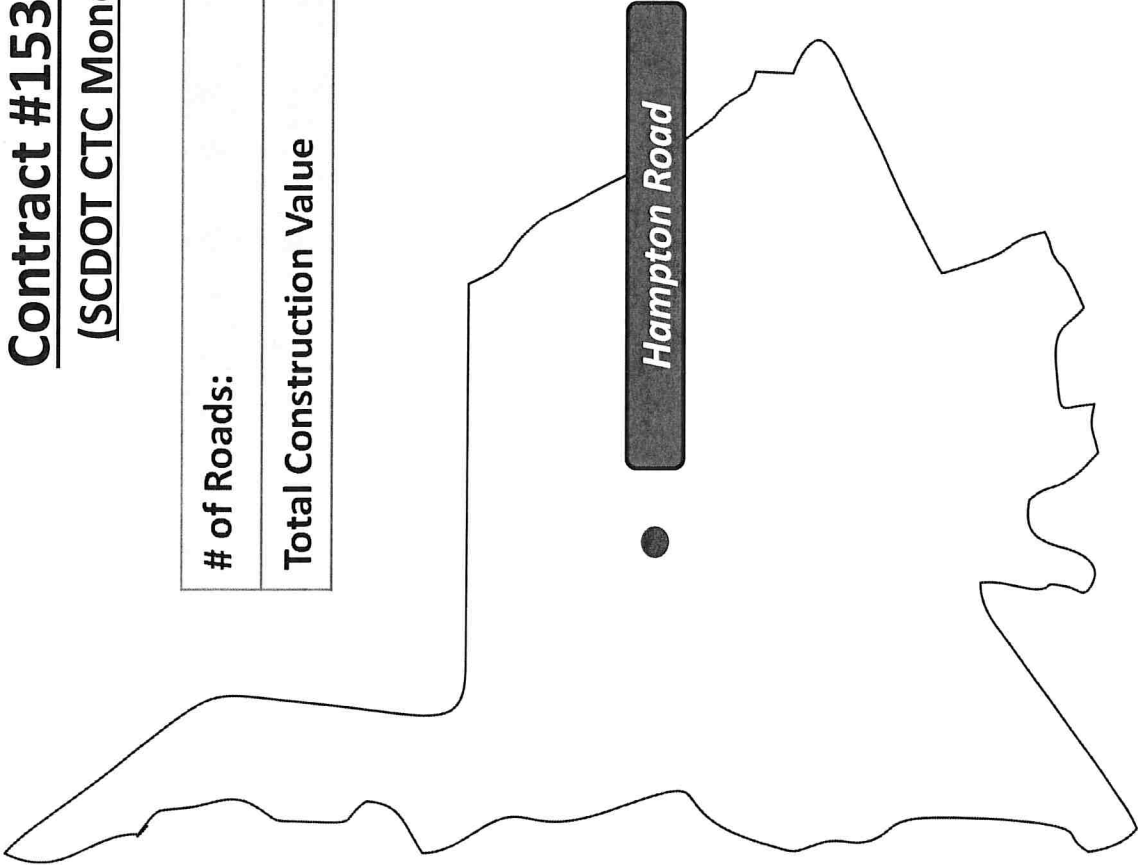
Overrun – Transportation Committee Funding

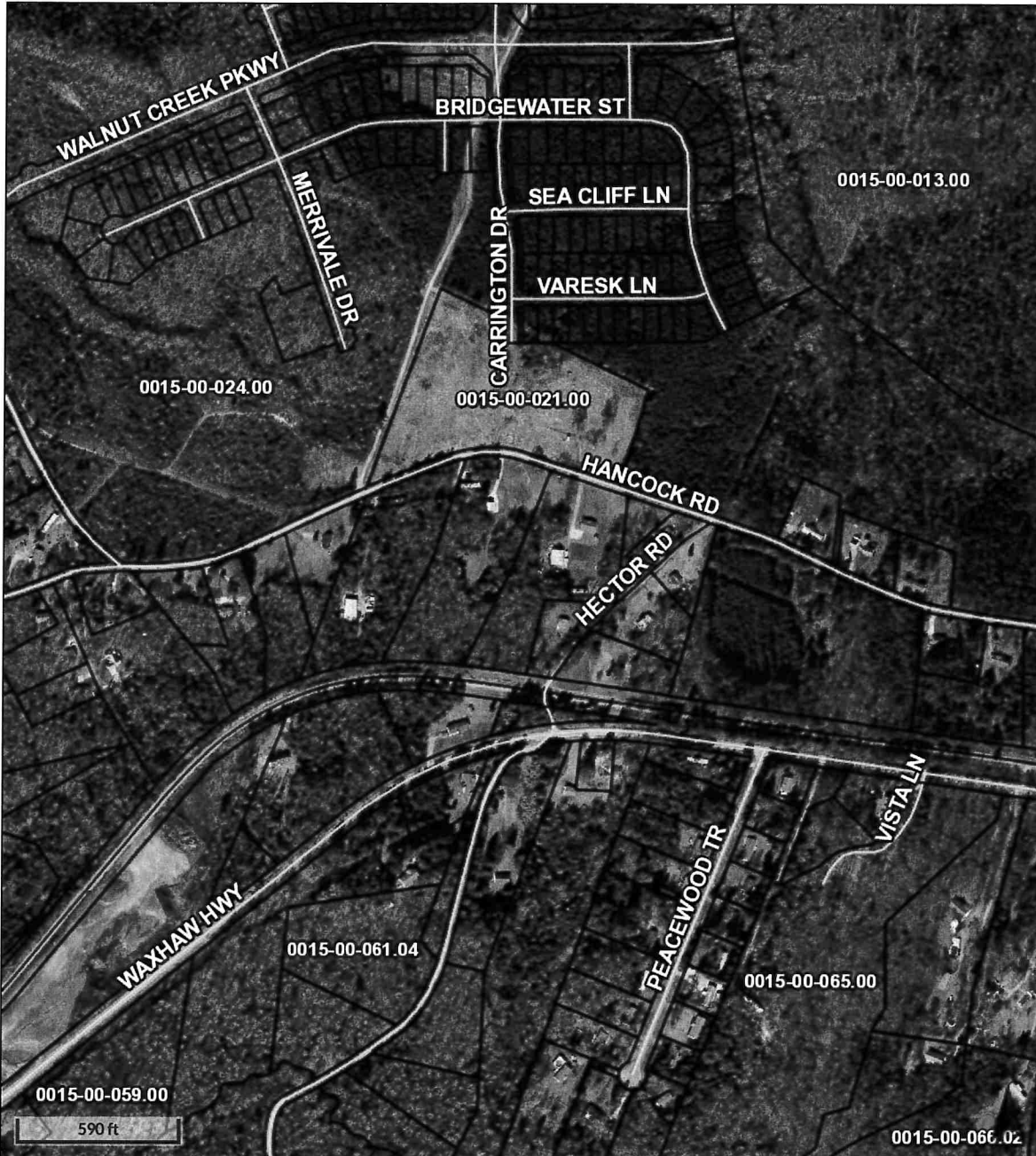
