Issue for Consideration: New Fire Apparatus has been purchased by Lancaster County for its Fire Rescue Service. The new apparatus necessitates the removal of older apparatus from the fleet once it arrives. The Fire Commission, as part of its purchase plan presented to Council in 2015, requested to be able to sell the apparatus coming off line with funds from the sale being dedicated to Rich Hill Fire Department for a needed building addition. The sale of the apparatus is anticipated to bring in \$200,000 to \$250,000. The Commission approved providing up to \$250,000 to Rich Hill FD for its building addition need in place of fire apparatus. The proposal was provided to Public Safety Committee in its July 14th, 2015 meeting. This request is for permission to proceed with bidding out the apparatus that will be decommissioned allowing time to explore all avenues and getting the best sale price available from the market to include dealers who purchase whole groups of used vehicles for resale. No sale will be made but anticipated revenue from a sale can be much better anticipated with this process moving forward.

<u>Points to Consider:</u> The decommissioned apparatus still has value due to the way the vehicles have been maintained and while they have passed their useful life in our firefighting system, there are agencies and organizations who are very much interested in the apparatus. Seeking bidders and dealers of used apparatus as well as listing the apparatus where other fire departments will be aware of its sale, will result in a much better sale value for the county and will hopefully provide the needed funds to fulfill the Fire Commissions plan for Rich Hill FD.

Funding and Liability Factors: This request does not require funding, however, it will deviate from the normal method of vehicle decommissioning in that the funds would be dedicated for a Volunteer Fire Department once they became available. The sale will occur in the next budget year and may need to be addressed in the budget documents as they are done so that an amendment would not be needed later on in the fiscal year. No liability will be incurred. All apparatus will be advertised and sold on an "As Is, Where Is" basis.


<u>Council Options:</u> Council may choose to allow permission to proceed with the plan to get pricing and prepare for the sale of the apparatus or Council can choose to dispose of the equipment in a usual manner once it is taken out of service.


Recommendation: Staff recommends the Fire Commission requested permission to explore sale to dealers and Fire Departments be allowed. The Fire Commission has voted unanimously to proceed with the maximum value sale of the apparatus that will be decommissioned.

Thank you for allowing MCON Construction Co., inc. the opportunity to provide pricing for the above referenced project. We will submit a user friendly proposal identifying items that may not be specified or totally identified, and in a few cases, an allowance will be given for those items.

GENERAL CONDITIONS (included):

- 1) Project Superintendent to supervise, schedule, coordinate and Insure quality workmanship for duration of the project.
- 2) Temporary toilet facilities for all construction workers.
- 3) Mobilization, daily clean-up, trash haul, final clean, required insurance and associated general conditions cost for our portion of the work.
- 4) Allowance of \$10,500 included for architectural plans for building permits.
- 5) Allowance of \$3,500 included for site plans sealed by a Civil Engineer.

<u>Issue for Consideration:</u> Acceptance of the formula driven Emergency Management Planning Grant (EMPG) known as the Local Emergency Management Planning Grant (LEMPG).

Points to Consider: This grant is awarded to Lancaster County Emergency Management on an annual basis based on a formula derived by SCEMD that takes into account a base amount and county population. The grant match is provided by existing Emergency Management Staff salaries, and EOC building expenses and contracts related to EOC functions.

<u>Funding and Liability Factors:</u> The match is provided by existing salaries and EOC expenses so no other county funds will be needed. No liability attaches. The grant funds upgrades to existing EOC equipment, IT, security and expenses for plan development. Lancaster County Emergency Management is a subgrantee to SC Emergency Management the Grantee of the EMPG from FEMA.

<u>Council Options:</u> Council may allow acceptance or direct the grant be turned down in which case Lancaster County's funds would be redistributed to other counties in SC.

Recommendation: Staff recommendation is to accept the grant as offered by SCEMD.

Dear Mr. Player:

This is the 2016 Local Emergency Management Performance Grant (LEMPG) application requirements notification. All required information to apply for the county grant is found at http://fip.cmd.sc.gov. The Username is ftpuser and the password is ftre@ndtee. A copy of this letter has been sent to your county administrator/manager for information. Your county's estimated annual award is \$58,644 which includes \$35,000 for EM Special Project funding. Your completed grant application is due to EMD by Friday May 27, 2016. Please note that this is not an award letter, but an application request to receive the grant funds. An actual award letter will be forwarded following SCEMD's award from the federal government.

The county will be reimbursed upon receipt of quarterly reports with supporting documentation of allowable expenditures. Each county will be responsible for providing the match for the grant award. If your county has elected to participate in WebEOC software, the yearly charge becomes part of the grant award and must be matched. Please note that the period of performance for the 2016 LEMPG is July 1, 2016 to June 30, 2017.

Of special note are the requirements outlined below:

- 1. Planning: LEMPG program participants must ensure EOPs are Comprehensive Preparedness Guidance (CPG) 101 v.2 compliant.
- 2. Exercises: LEMPG program funded personnel, to include personnel used as match, must participate in no less than three exercises in a 12-month period.
- 3. Training: LEMPG program funded personnel, to include personnel used as match, must complete the following training requirements: IS-100.b, IS-200.b, IS-700.a, IS-800.b, IS-120 or IS-139, IS-230.d, IS-235.b, IS-240.a, IS-241.a, IS-242.a, and IS-244.b.
- 4. The CERT program is now funded with LEMPG funds that must be matched by the county. Counties that want to participate must request the additional CERT funds up to a maximum of \$9,000.00, add to their budget submission and include as a scope of work item.
- 5. The Department of Homeland Security adopted 2 C.F.R. Part 200. The provision of 2 C.F.R. Part 200 will apply to all sub-recipient grant awards.

A 2016 LEMPG checklist has been added in the FTP site to assist in preparing the application.
