Call to Order

Chairman Brian Carnes called the meeting to order at 4:30 p.m.

Approval of Agenda

Councilwoman McGriff moved to approve the agenda. SECONDED by Councilman Bundy. Passed 3-0.

Minutes of the February 11, 2016 Meeting

Discussion/Action

Potential Business Registration Ordinance

County Administrator Steve Willis stated that a draft ordinance is included in the package for review, stating that a business registration is different than a business license. A business registration has no mandatory fee and is capped at \$15 per year, whereas a license is based on business gross receipts for the year and could be audited. Mr. Willis stated that the program would be administered by the Delinquent Tax Collection Office, should Council elect to adopt the Business Registration ordinance. There would be some expense related to the program involving printing of the permit and mailing it to the business, but staff is still working to quantify. Mr. Willis stated that staff has purposely limited the applicability of the ordinance to avoid small businesses.

Councilwoman McGriff stated that if Council adopts the ordinance, she would want it to be business friendly as possible, as the County would get more cooperation from businesses. Councilman Bundy agreed with Councilwoman McGriff.

Mr. Willis made note that the intention is not to invade a business finances, but simply to have an account of all businesses operating in the county.

This item will be back on the next agenda with information from staff regarding the threshold for filing and the definition of a small business as to who has to file.

Potential donation of land to the Lancaster County School District

Mr. Willis stated that parcel #0058-00-008.00 is just less than one half acre owned by the County and is within the Buford School complex. He stated that it has been suggested that it might make a good site for a parking/holding area for parents waiting to pick up their child from the Buford Middle School.

Councilwoman McGriff made the motion to recommend to full Council for consideration. Seconded by Councilman Bundy, passed 3-0.

Walnut Creek Ordinance to enlarge the district and revise the assessment rolls

County John Weaver stated that the issue for consideration is authorizing modifications to Walnut Creek improvement District, formerly known as Edenmoor Improvement District. It includes enlarging the District to add two parcels therein to Bond Area 2 and Bond Area 3; authorizing not to exceed \$6,000,000 principal amount of Assessment Revenue Bonds, relating solely to Bond Area 2 and Bond Area 3.

Councilwoman McGriff made the motion to recommend to full Council for consideration. Seconded by Councilman Bundy, passed 3-0.

Budget Calendar

Kim Hill, Budget Analyst presented the Committee with the budget calendar. Ms. Hill stated that the budget process is going well and the completed recommended budget will be sent out
