AN ORDINANCE

TO AMEND THE OFFICIAL ZONING MAP OF LANCASTER COUNTY SO AS TO REZONE A ± 1.00 ACRE TRACT OF PROPERTY OWNED BY SUZANNE AND FRED MANGANO, LOCATED AT 1832 EVANS DRIVE, LANCASTER, SC 29720 (A PORTION OF TAX MAP NO. 0087-00-095.08) FROM LDR, LOW DENSITY RESIDENTIAL DISTRICT TO MH, MANUFACTURED HOME DISTRICT.

Be it ordained by the Council of Lancaster County, South Carolina:

**Section 1.** Findings and Determinations.

The Council finds and determines that:

(a) Suzanne Mangano and Fred Mangano applied to rezone property located at 1832 Evans Drive, Lancaster, SC 29720 (Tax Map No. 0087-00-095.08) from LDR, Low Density Residential District to MH, Manufactured Home District.

(b) On February 19, 2019, the Lancaster County Planning Commission held a public hearing on the proposed rezoning and, by a vote of (7-0), recommended approval of the rezoning.

(c) The Future Land Use Map identifies this property as urban based on the *Lancaster County Comprehensive Plan 2014-2024*. Properties in the immediate vicinity contain manufactured homes and placement of a mobile home on the subject property would be a compatible use. The rezoning of the property to Manufactured Home District is compatible with the Future Land Use Map and Comprehensive Plan.

**Section 2.** Rezoning.

The Official Zoning Map is amended by changing the zoning district classification from LDR, Low Density Residential District to MH, Manufactured Home District for the following property as identified by tax map number or other appropriate identifier:

A portion of Tax Map No. 0087-00-095.08 (1.00 acre, more or less)

**Section 3. Severability.**

If any section, subsection or clause of this ordinance is held to be unconstitutional or otherwise invalid, the validity of the remaining sections, subsections and clauses shall not be affected.

**Section 4. Conflicting Provisions.**

To the extent this ordinance contains provisions that conflict with provisions contained elsewhere in the Lancaster County Code or other County ordinances, the provisions contained in this ordinance supersede all other provisions and this ordinance is controlling.


**Section 5. Effective Date.**


This ordinance is effective upon Third Reading.


