I will read and follow all of the rules of the La Plata County Fair. I will also read and follow the Colorado State Law concerning the unlawful alteration of livestock, where applicable, by tampering or sabotage and the United State Department of Agriculture Wholesome Meat Act. I will ask that my parents and supervisors also understand and follow these rules and not make or ask for exceptions on my behalf. I wish for my animal project to be an example of how to accept what life has to offer – good or bad – and how to live with the outcome.

I understand that I am responsible for the proper care and treatment of my animal, the production of wholesome food, where applicable, and the development of sound moral character.

I do hereby state that the horse(s) entered are recorded in my 4-H Horse Project Record Book and 4-H Horse Certificates are on file in the Extension Office.

The care, feeding, and safety of animals brought to the La Plata County Fair shall be the responsibility of the person exhibiting such animal(s). La Plata County Fair shall not insure nor be responsible for the safety of such animals or the person tending them. Signature on entry form by the exhibitor and parent/guardian shall be deemed acceptance of all rules, including those on pages 6, 87, 88, 94 & 95 of the 2019 La Plata County Fair Premium Book. The exhibitor therefore indemnifies the La Plata County Fair from any and all legal proceedings in regard thereto.

**Show Rules:**

Rules and patterns used for 4-H Open shows and gymkhana will come from Colorado 4-H Horse Show Rule Book 2018. "The rules encourage judging and competition that reflect the standards of skill and abilities in horsemanship emphasized by the Colorado 4-H Horse Program."

**Owner/Trainer** – Weanlings are horses born in 2019, Yearling: born 2018, 2-Year Olds: born 2017, 3-Year Olds: born 2016. Weanlings thru 2-Year Olds should be ready to show by 9am untacked. Exhibitors with 2-year olds should have tack ready by arena fence. Order and instructions will be called before class. Exhibitors with 3-year olds should have a pattern chosen to ride for the judge that will show required skills listed in the project/record book.

**Protective Headgear Policy** rule book pg. 2 - Because 4-H promotes safety first, we require a certified equestrian helmet with safety harness fastened in place for over fences classes and all gymkhana events. Protective head gear may be used in all classes and shall not be discriminated against. La Plata County 4-H Horse Council will provide helmets for those who do not have one.
