*Sales Tax is two-months in arrears. The amounts are reported in the month the revenue is earned. The amounts reported include General, Road & Bridge, Capital Improvement and Joint Sales Tax Funds receipts.

** - This decrease is attributable to the receipt in January 2016 of back taxes resulting in a net amount to the County of \$43,838. With this net amount excluded, there is a decrease of approximately 1.29% in January 2017 over January 2016.

*** - This increase is attributable to onetime collections based on the sale of assets and a 2016 late filing resulting in a net amount to the County of \$445,673. Without these anomalies there is an increase of approximately 1.1% in July 2017 over July 2016.

**** - This increase from October of 2016 to October of 2017 is largely attributable to payment of sales taxes in the currency period for prior months sales. Removing late filings received from each October's totals shows a decrease in the County's portion of sales taxes collected for October of \$35,944; the result of this adjustment is an increase from the prior October of \$106,576, or 8.5% increase.
