A RESOLUTION ESTABLISHING A DOWNTOWN LOGAN SPECIFIC PLAN

**WHEREAS**, the Municipal Council finds that the economic and physical condition of Downtown Logan is of significant importance to the vitality of the City of Logan and Cache Valley; and

**WHEREAS**, the Downtown Logan Specific Plan guides future development, transportation enhancements, and recommended market and economic restructuring for the downtown over the next 40 years; and

**WHEREAS**, the Downtown Logan Specific Plan implements the economic, housing, and design goals of the Logan General Plan as this Specific Plan acknowledges the importance of maintaining and promoting the vitality of downtown; and

**WHEREAS**, the Downtown Logan Specific Plan is consistent with, and actively promotes, the Historic District Design Standards for those downtown areas that lie within the historic district; and

**WHEREAS**, a lengthy public process was utilized to develop and prepare this Specific Plan in order to ensure both property owners and Logan residents alike had a chance to actively participate in the Downtown Logan Specific Plan; and

**WHEREAS**, the Logan Downtown Alliance supports this plan and is committed to the realization of its stated objectives.


