ResolutionA RESOLUTION APPROVING AGENCY ASSISTANCENo. 12-33 RDAFOR A FAÇADE IMPROVEMENT PROGRAM IN THE
DOWNTOWN REDEVELOPMENT AREA (RDA)

WHEREAS, the City of Logan has adopted policies for assistance in projects and improvements in Redevelopment and Economic Development Project Areas; and

WHEREAS, the City of Logan has adopted principles within its General Plan to preserve Logan's distinctive character and to preserve and improve its Historic Downtown; and

WHEREAS, the City of Logan has adopted the Downtown Logan Specific Plan which encourages the creation of a commercial façade improvement program as part of its accompanying Implementation Plan; and

WHEREAS, the Logan Downtown Façade Program ("Program") (see attached 2012 Downtown Façade Program) would encourage, through the use of incentives to be determined by the City's Economic Development Committee, exterior improvements to buildings, facades and storefronts in the downtown area bounded by 500 North, 300 South, 100 East and 100 West, which area includes properties fronting both sides of these roads (see attached map); and

WHEREAS, the "Project" would encourage further economic development in Downtown Logan; and

WHEREAS, the Economic Development Committee has reviewed the proposed investment and recommends its approval;

NOW THEREFORE BE IT RESOLVED, that the Redevelopment Agency of the City of Logan does hereby resolve to appropriate \$30,000 annually for the "Program" for fiscal years 2013 and 2014 to assist eligible building and storefront rehabilitation projects lying within the Downtown RDA boundaries, a subdivision of the broader "Program" area.

Additionally, the Redevelopment Agency encourages property owners to utilize local contractors and vendors whenever possible.



2012 DOWNTOWN FAÇADE PROGRAM

APPLICATION FOR FUNDING ASSISTANCE

The City of Logan is pleased to offer a grant program intended to stimulate investment in downtown building facades. The program is designed to assist rehabilitation projects of varying scope. These may range from smaller painting, lighting, or awning replacement projects to the more extensive storefront modifications or complete façade overhauls. Property renovations may include efforts to enhance parking areas.

Interested property owners may apply for a matching grant of up to *25%, not to exceed \$35,000. The property must be located within the program boundaries located in Downtown Logan (see map on following page). The availability of matching funds varies by location within the program area due to restrictions associated with the source of funds. Applicants must provide architectural renderings of the proposed renovations.

Historic preservation projects are encouraged and may be eligible for federal tax credits administered by the <u>National Park Service</u>. Projects proposed within the Center Street National Historic District will need to adhere to principles outlined in both federal law, <u>Secretary of the Interior's Standards for</u> <u>Rehabilitation</u>, and in the City of Logan's <u>Historic District Design Review Standards</u>. Approval Process and Important Dates

1. Applications are to be returned to the Community Development Department during the application period (shown below). As appropriate, this façade program application must be accompanied by a project review application and/or a historic certificate of appropriateness application, as directed by the Community Development Department.

May 16 Application period opens June 21 Application period closes

 Projects will be reviewed and recommended for funding by a Façade Program Committee to then be presented to the City's Economic Development Committee for final approval on July 11th.

* Projects may be eligible for grants of up to 50% of total project cost if approved by the City's Economic Development Committee.



2012 DOWNTOWN FAÇADE PROGRAM

Factors considered for possible increased match of up to 50% of total project cost

The following project criteria will be considered by the Façade Program and Economic Development Committees as potential factors providing possible justification for a larger matching grant percentage of total project cost:

- Project location within the Center Street National Historic District
- Total project cost
- Owner equity
- Degree of historical preservation proposed for 'Contributory' structures, as defined on the 1999 Reconnaissance Level Survey
- Degree of architectural and design enhancements
- Perceived impact on both the immediate neighborhood and Downtown


